





CLOSING CONSOLIDATED PUMP & TANK PROJECT**

WHEREAS, beginning in March 2016, proceedings have been held to consider the joint increase and improvement of facilities of the Town of Eden Consolidated Water District and Water Districts No. 1, 2, 3, 3A (hereinafter "Pump & Tank Project), in said Town, and

WHEREAS, the Eden Town Board has received satisfactory documentation confirming that all work on Pump & Tank Project is completed and has been accepted upon recommendation of project engineers and the Town of Eden seeks to formally close this project.

NOW, THEREFORE, it is hereby

RESOLVED, that the Eden Town Board does hereby declare the Pump & Tank Project as "closed", and it is further

RESOLVED, that the Eden Town Board does hereby report the sum of \$72,926.44 as the balance remaining on the Pump & Tank Project to be used for debt.
