INSTRUCTIONS

Effective immediately, ALL Solicitor and Peddler permit applicants are required to have a criminal background check completed prior to issuing these permits. In order for the Department of Criminal Justice Services (DCIS) to provide us with your criminal history, all applicants must be fingerprinted. New York State does NOT allow the town of Eden Police Department to do these fingerprints. All Solicitor and Peddler fingerprints must be completed by the "L-1 Enrollment Process" per the instructions below. Once your fingerprints are completed, your criminal background check will be forwarded electronically to the Town of Eden Police Department for review and subsequent approval or denial.

THE APPLICATION PROCESS

- (1) Schedule and have your fingerprints completed, see instructions below
- (2) Complete this Solicitor and Peddler Permit Application
- (3) Submit completed application to the Town Clerk's Office along with the fee of \$10.00. Submit (3) 2" x 2" photos showing head, full face and shoulders – taken within last 6 months. Photo I.D. is also required.
- (4) Within 10 business days after we receive your criminal background check from DCIS, you will be contacted by phone on your approval or denial of this application
- (5) If approved, you must report to the Town Clerk's office to pick up the Solicitor and Peddler Permit which is valid all days between the hours of 9:00 a.m. and 8:00 p.m. from the date of issuance for a period of 60 days thereafter

THE FINGERPRINT PROCESS

New York State requires that all solicitor and peddler permit applicant fingerprints MUST be completed by the following process. To find a fingerprint location near you and to schedule an appointment call toll free (877)472-6915 or register online at www.L1enrollment.com

Fingerprints and the subsequent criminal background check are good for one year.

IF APPROVED

Every solicitor or peddler will be issued a permit, which will include their name, photograph and expiration date of permit. When engaged in soliciting or peddling, this permit MUST be worn or placed on the outer most garment and the photo side MUST be visible to the public, which would be supplied by the company.

This permit is only valid within the Town of Eden and is NOT transferable.

Any violation of this chapter shall be punishable by a fine of not less than \$10.00 nor more than \$50.00, and in default of payment of said fine, by imprisonment for a term of one day for each dollar of the fine imposed.
