North Collins has their "Fee" listed at such in their code:

[Amended 12-4-1991 by L.L. No. 2-1991]

A fee as set forth from time to time by resolution of the Town Board shall be paid by the applicant for each such license.

We should up-date ours to follow suite and then have the board pass a fee increase to \$100. Once the code has been up-dated.

Information on obtaining a solicitor permit in the Town of Eden was recently requested which prompted me to review our current fee of \$10. I believe this fee should be increased as it is an unrealistic number for the amount of work involved. First, a number of steps need to be done in order to apply for the permit, including:

-Give application to applicant and answer any questions -Get fingerprints (sent to police) - - applicant pays for this -Return application to Town Clerk with \$10 Fee, Town Clerk signs off on application -Give application to police who run a background check etc and sign off on application (Kim said this process can take 10 minutes or up to an hour) -Return application to Town Clerk who then contacts applicant to pick up

We currently rarely receive a application however the above steps are costing the Town more than the \$10 fee. I would suggest increasing the fee to \$100 (60 days) .

I did also poll of local municipalities and what they charge for the Solicitor Permits:

Eden \$10

Lancaster \$0

West Seneca \$75

East Aurora \$15 plus \$2 per day

North Collins \$10

Hamburg \$100 - 60 days

Concord \$150 - 60 days

Cheektowaga \$100 - 6 months + \$10 to police for back ground check Amherst \$50

If this can be incorporated in some type of future fee schedule up-date that would be best as long as it is not much cost or time.
