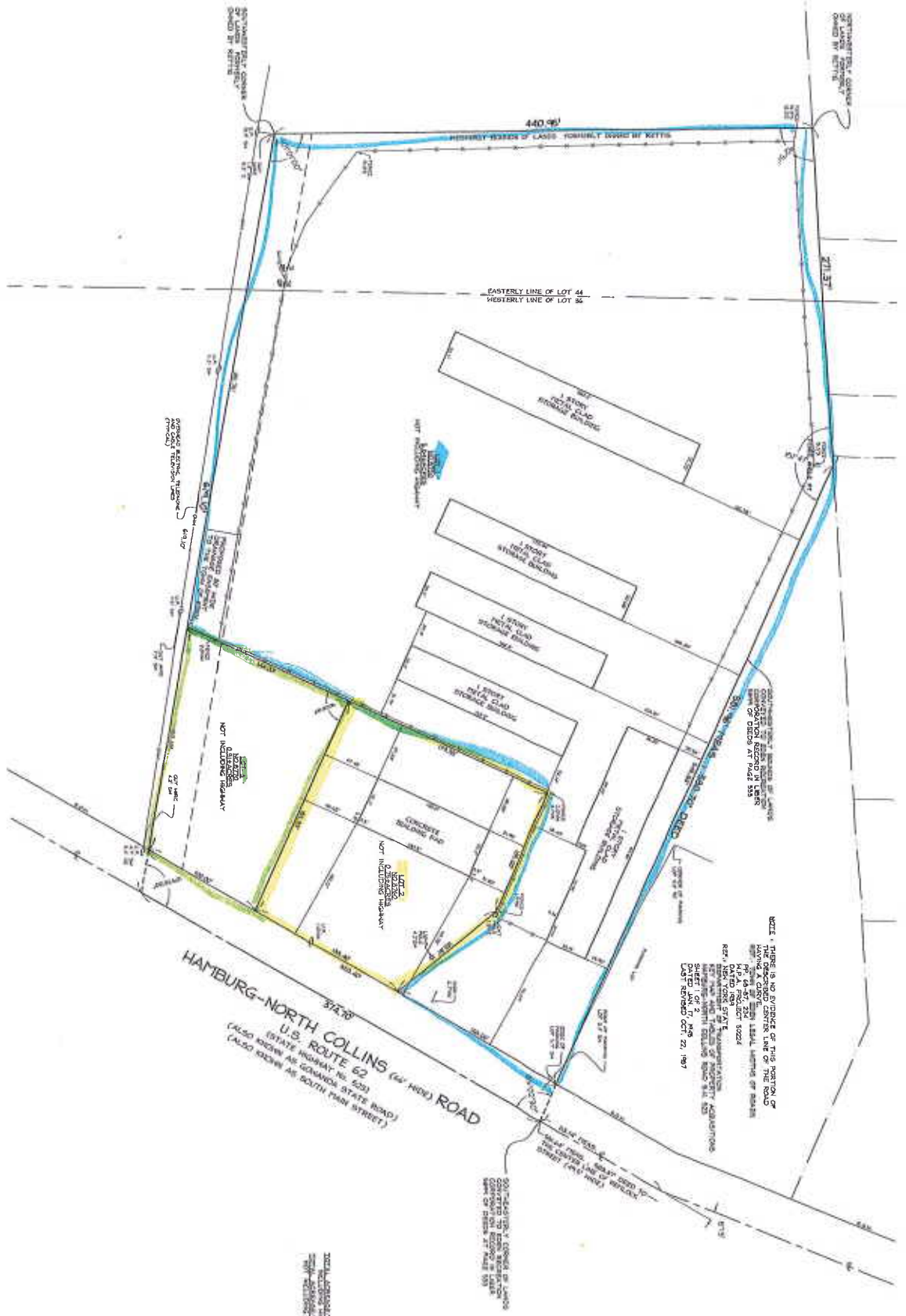




Melissa Cataldo as Swim Instructor at a rate of \$10.90 per hour.
