**WHEREAS,** as a result of pre-trial negotiations, the parties have agreed to settle these proceedings on terms which will result in prospective relief in the form of reduced assessments in the future with no liability for tax refund, and

**WHEREAS**, these terms of settlement have been reviewed and recommended by the Board of Assessors and the Town Attorney,

**NOW, THEREFORE** the Town Board of the Town of Eden hereby authorizes the Town Attorney to execute the Settlement Agreement on behalf of the Town of Eden and to obtain Court Orders confirming the terms of the said Settlement Agreement.

#### 2.) Erie County Personnel Office
