Call To Order:

Supervisor Nellis called the Work Session of the Eden Town Board to order at 7:30 P.M.

Pledge of Allegiance:

Supervisor Nellis led the assembly in the Pledge of Allegiance to the flag followed by a moment of silence.

New and Unfinished Business:

1. Eden Emergency Squad – Repair of Vertical Light Tower

Scott Hultquist and John Sheffer were present to make recommendation to the Town Board regarding two quotes received to repair the Vertical Light Tower. One quote was from the manufacturer, The Will-Burt Company in the amount of \$3,150.00 and the second quote was from William Shoemaker in the amount of \$3,388.00.

The recommendation is to award the bid to The Will-Burt Company in the amount of \$3,150.00. The Town Board was assured that sufficient funds were available in the 2007 Emergency Squad budget.

MOTION was made by Councilwoman Pew to award the bid to repair the Vertical Light Tower to The Will-Burt Company in the amount of \$3,150.00; seconded by Councilman Krycia; All "Ayes"; Opposed? - None; Abstain? - None; Motion carried.

2. Time-Warner Cable Franchise Renewal

Councilwoman Pew stated that the Code Review Committee and the Technology Committee had previously met and discussed the Time-Warner Cable Franchise renewal. After much discussion the committees decided to seek input to put together a draft proposal, which would then be submitted to William Trask, Town Attorney for his review. Councilwoman Pew stated that the franchise expires August 2008.

Supervisor Nellis stated that this item would be tabled and moved to "Old Business" to be reviewed and discussed at a future Town Board Meeting.

3. Request from Highway Superintendent to create an additional part-time laborer position

Supervisor Nellis read correspondence from Ron Maggs, Highway

Superintendent regarding additional part-time laborer positions to be used during busy times, vacations, and sick time. Currently the Highway Department has six part-time positions filled, as allowed by Erie County Personnel Department. Mr. Maggs is recommending making a request to Erie County Personnel Department to add one more part-time position.

After much discussion the following motion was offered:

MOTION was made by Councilman Ventry to make request to Erie County Personnel Department to add two part-time positions to the Eden Highway Department, which would be a total of eight part-time positions, and would not impact the highway budget; seconded by Councilman Krycia; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

4. <u>Correspondence from Rural Transit Service, Inc., Re: Support of the Van</u> Program through the 2008-2009 Community Development Block Grant Year

Supervisor Nellis read correspondence from Brenda Henderson, Executive Director for Rural Transit Services, Inc. regarding a resolution authorizing the Town of Eden to support the van program for the 2008-2009 Community Development Block Grant year.

MOTION was made by Supervisor Nellis to support the van program for the 2008-2009 and list it as such on the Community Development Block Grant application; seconded by Councilwoman Pew; All "Ayes"; Opposed? – None; Abstain? - None; Motion carried.

5. <u>Presentation on Strategies and Action Steps for Tourism Development in the Southtowns of Erie County</u>

Supervisor Nellis gave a presentation, which is on file in the Town Clerk's office, A "Tourism Toolkit", Strategies and Action Steps for Tourism Development in the Southtowns. Meeting on a monthly basis, representatives from the seven towns/villages are moving forward to find ways to attract people to stop and shop in the unique shops and dine in the local restaurants.

Supervisor Nellis explained the purpose of the public hearing is to listen to any concerns or questions that citizens have. Supervisor Nellis stated that up to \$90,000.00 is available in areas of the Town of Eden defined as having sufficient low and moderate income.

The following persons spoke:

Mike Bolo, 9998 Clarksburg Road, suggested signage coming into and going out of Eden on the North and South ends of Town. Later in the meeting a student suggested the same.

Frank Mantione, 2722 Kulp Road, suggested the Chamber Park, as it is in disrepair and the maintenance should be contracted out to a professional landscaper. Mr. Mantione also suggested building a Senior Citizen Center and repairs to the ASA Warren Historical House at 8639 S. Main Street.

Councilman Krycia suggestion sidewalk repairs, if needed throughout the Town.

Robert Stickney, 2718 Lourdes Drive, suggested landscaping around the Town Hall and preservation of the front of the Town Hall building.

All persons desiring to be heard, having been heard, Supervisor Nellis closed the Public Hearing at 8:25 p.m.

A mandatory training requirement for Planning and Zoning Board of Appeals went into effect as of January 1, 2007 to fulfill four-hours of training required under the new law.
