# 1. 2008 Payroll Correction

"As you may recall, at the beginning of this year, we needed to make a correction to the rate per hour for Jane Henry, Dispatcher, as we never increased her rate by the 3%

from 2006 to 2007. Now, in reviewing our financial records, we find that although we have been paying Jane the correct amount per hour (3% over 2007) for this year, the minutes were still showing the 2007 rate. To satisfy our auditor, could the Board please approve a simple motion stating that the rate of pay for Jane Henry for 2008 is \$11.54. I have double-checked to make certain that the draft Re-organizational minutes show Jane's new rate for 2009 is 4% above the 2008 rate, or \$12.00 per hour."

# REORGANIZATIONAL MEETING FOR THE YEAR 2009 TOWN OF EDEN

Supervisor Nellis began the Re-organizational Meeting by reading the following items:

- 1. Regular meetings of the Eden Town Board will be held on the second Wednesday of each month starting at 7:30 P.M. Additional meetings will be held on the fourth Wednesday of each month as needed.
- 2. The official newspaper of the Town of Eden will be <u>"The Sun"</u> located in Hamburg, New York.
- 3. Surety Bonds will be carried as follows:

\$490,000.00 – Tax Collector \$40,000.00 Supervisor \$24,000.00 – All Others

- 4. Mileage reimbursement will be \$.40 per mile while using personal vehicles on Town business, authorized in advance.
- 5. Copies of adopted minutes will be on file at the Eden Library and the Town Clerk's office.
- 6. Appoint HSBC, M & T, Evans National & Bank of America and other institutions as deemed appropriate by the Board, as banks for deposits, checking and investments.

- 6. Highway Superintendent, Ronald Maggs at \$61,093.00 yearly, to be paid biweekly.

The Chairman of the Assessment Board of Review is to be paid \$125.00 yearly and the other members of the Assessment Board to be compensated \$85.00 each yearly. A secretary, if needed, will be compensated \$200.00 per year.

Deputy Town Clerk Heather Ohmit will be paid \$10.63 per hour. Deputy Town Clerk Cynthia Ciesielski will be paid \$10.32 per hour. The hours and salaries of the Town Clerk's office shall not exceed a total of 1,450 Deputy Clerk hours or \$15,228.00 for the year.

Appoint Mary Jo Hultquist, Registrar, at a rate of \$3,129.00 yearly, to be paid monthly.

Appoint William Sickau part-time custodian at 40 hours per month at \$12.38/hr. to be paid monthly.

Appoint Raymond Zabron, part-time Dog Control Officer, at an annual salary of \$12,825.00, to be paid monthly.

Appoint Maureen Zabron, part-time Dog Control Officer's secretary at an annual salary of \$2,731.00, to be paid monthly.

Appoint Susan Brass, Recreation Director at \$19,266.00 yearly, to be paid monthly.

Appoint Scot Christiansen, Recreation Working Crew Chief, at \$21.00/hr., to be paid biweekly.

Appoint Cynthia Kugler, secretary to the Highway Superintendent at \$12.06 per hour for 40 hours per week, to be paid bi-weekly.

Appoint Michael Kobiolka, Town Prosecutor, at annual salary of \$5,415.00, to be paid monthly.

Appoint William J. Trask, Sr., Town Attorney to provide legal services for the Town at an annual compensation of \$27,400.00, to be paid monthly.

Kim Soda, Full-Time Police Dispatcher will be compensated \$37,440.00 for the year, to be paid bi-weekly.

Part-time Police Officers will be paid \$16.00 per hour for Day Shifts, not to exceed 1768 hours and \$28,288.00 and \$17.00 per hour for Night Shifts, not to exceed 1000 hours and \$17,000.00 not to exceed a total expenditure of \$45,288.00 for all part-time officers for the year.

Part-time dispatchers will be paid \$9.56 per hour with the exception of Jane Henry, who will be compensated \$12.00 per hour. Total dispatching allotment shall not to exceed the budgeted authorization of \$37,890.00 per year.

Appoint Thomas Jones, Rose Nadrich, Nick Blasz, Teresa Bishop, Diana DeCarlo, Julie Boedo, Seth Howard and Jane Henry part-time Police Dispatchers; Joseph Flynn, Michael Felschow, Jeffrey DeVinney, Greg Szarowicz, Mark Baltes, Donald Hoelscher and Michael Rich part-time Police Officers.
