3. <u>Set New Date for Public Hearing for Proposed Establishment of Town of</u> <u>Eden Water District No. 5</u>

William Trask, Town Attorney read the following order calling Public Hearing:

ORDER CALLING PUBLIC HEARING TO BE HELD ON FEBRUARY 8, 2010 REGARDING THE PROPOSED ESTABLISHMENT OF TOWN OF EDEN WATER DISTRICT NO. 5

WHEREAS, the Town Board of the Town of Eden (herein called 'Town Board" and "Town", respectively), in the County of Erie, New York, has, pursuant to Town Law Article 12-A, caused CRA Infrastructure & Engineering, Inc. competent engineers duly licensed by the State of New York, to prepare a map, plan and report for the establishment of Water District No. 5 (the "District"), which map, plan and report is on file at the office of the Town Clerk, and available for public inspection at said location; and

WHEREAS, said map, plan and report proposed a water system to be installed along roadways and within right-of-ways previously disturbed by the construction of roads, ditches and utilities. The District will receive water from the Erie County Water Authority through various transmission mains. Approximately 23,100 lineal feet of 8-inch waterline will be installed along roadways in the District including, but not limited to, Ferrier Road, March Road, Shadagee Road and Hemlock Road, including all related right-of-way costs, new service installation, site work and other ancillary work, including hydrants, valves, apparatus, preliminary costs and other improvements and costs incidental thereto (collectively referred to herein as "Water Improvement"); and

WHEREAS, the proposed District is bounded and described as follows:

Eden Water District No. 5-Boundary 5A

WHEREAS, the maximum amount proposed to be expended for the Water Improvement is estimated to be \$2,550,000; and

WHEREAS, in addition to the benefits specifically attributable to the residents in the proposed District, the construction of the Water Improvement will also provide the following benefits to all existing (and proposed) water districts and customers: (i) improve the quality of the public water supply; (ii) improve the stability of the entire water supply; (iii) increase transmission capacity by connecting to the existing system and looping the waterlines; (iv) improve fire flow protection; and (v) remove dead end water lines; and

WHEREAS, in light of the overall improvements the Water Improvement will have in the existing districts, the Town Board has determined to allocate approximately 20% (approximately \$550,000) of the cost of the Water Improvement to residents in the existing water districts through a separate Town proceeding scheduled to take place at a later date and intends to levy special assessments against the properties in the existing districts as determined by law; and

WHEREAS, the balance of the cost of the Water Improvement attributable to the residents in the proposed new District is \$2,000,000, which amount is to be

financed by the issuance of serial bonds in an amount not to exceed \$2,000,000, offset by any federal, state, county and/or local funds received and the assessment, levy and collection of special assessments from the several lots and parcels of land within the District which the Town Board shall determine and specify to be especially benefited thereby, so much upon and from each as shall be in just proportion to the amount of benefit conferred upon the same, to pay the principal of and interest on said bonds as the same shall become due and payable, except as provided by law; and

WHEREAS, the expected average annual cost to the Typical Property (as defined by Town Law) in the proposed District (which is a single family home) during the first year will be approximately \$875 (such amount includes construction financing costs (debt service), estimated annual water usage costs and hydrant fees); and each property will also have to provide for service from their home to the property line and internal plumbing modifications to set a meter and valves at an estimated one-time cost of approximately \$1,500.

NOW, THEREFORE BE IT

ORDERED, that a meeting of the Town Board of the Town be held at the Eden Central High School, 3150 Schoolview Road, Eden, New York, on February 8, 2010, at 7:00 o'clock p.m. (Prevailing Time) to hear all persons interested in the Establishment of the Town of Eden Water District No. 5, and for such other action on the part of the Town Board with relation thereto as may be required by law; and be it

FURTHER ORDERED, that in the event that the Town offices and/or the Eden Central School District schools are closed on February 8, 2010 due to inclement weather (or for any other reason), the public hearing will be held at the Eden Central High School, 3150 Schoolview Road, Eden, New York on February 11, 2010 at 7:00 o'clock p.m. (Prevailing Time); and be it

FURTHER ORDERED, that the Town Clerk publish at least once in the newspapers designated as the official newspapers of the Town for such publication, and post on the sign board of the Town maintained pursuant to subdivision 6 of Section 30 of the Town Law, a copy of this Order, certified by said Town Clerk, the first publication thereof and said posting to be not less than ten (10) nor more than twenty (20) days before the date of such public hearing, and be it

FURTHER ORDERED, that the Town Clerk mail by first class mail to each owner of the taxable real property in the District, a copy of this Order, or a summary thereof; and be it FURTHER ORDERED, that the Town Clerk shall file a certified copy of

this Order with the Office of the State Comptroller, on or about the date of publication of this Order.

6. <u>Resolution on World Kidney Day – March 11, 2010</u>

Supervisor Nellis read the following resolution:

PROCLAMATION Recognizing March 11, 2010 as "World Kidney Day"

WHEREAS, healthy kidneys are essential to regulate the body by water and other chemicals in your blood, remove fluids, waste, toxins and drugs introduced to the body, release hormones that regulate blood pressure, make red blood cells and promote strong bones; and

WHEREAS, more than 26 million Americans, about one in nine adults, suffer from chronic kidney disease; and

WHEREAS, 170,000 Western New Yorkers have chronic kidney disease and another 170,000 are at risk and don't know it; and

WHEREAS, over 1,600 Western New Yorkers are on dialysis; and

WHEREAS, approximately 40 percent are African American and 16 percent are Hispanic; and

WHEREAS, the two main causes of chronic kidney disease are diabetes and high blood pressure, which are responsible for up to two-thirds of the cases; and

WHEREAS, the National Kidney Foundation of WNY as a free health screening program to identify people in the early stages of kidney disease; and

WHEREAS, the mission of the National Kidney Foundation of WNY is to prevent kidney and urinary tract diseases, improve the health and well-being of individuals and families affected by these diseases, and increase the availability of all organs for transplantation; and

WHEREAS, early detection including regular reporting of the GFR calculation, currently the best indication of kidney disease staging can help prevent the progression of kidney disease failure, which requires continual dialysis or kidney transplant to maintain life; and

WHEREAS, the cost of treatment for kidney disease patients is disproportionately higher than any other chronic disease; and

WHEREAS, most patients who have end-stage renal disease rely primarily on Medicare and Medicaid to cover the costs of their life-sustaining care, which includes dialysis treatment, medications, laboratory testing, and as necessary, transportation services to the dialysis facility, and as a consequence, any changes in Medicare and Medicaid eligibility, significantly put them at risk;

NOW, THEREFORE BE IT RESOLVED by the Eden Town Board that March 11th is recognized as "World Kidney Day" in the Town of Eden in the hope that all possible support will continue to be extended to Chronic Kidney Disease patients in New York State and throughout the country and the world.

MOTION was made by Supervisor Nellis to adopt the Proclamation as presented; seconded by Councilwoman Pew; All "Ayes"; Opposed? – None; Abstain? - None; Motion carried.
