Supervisor Nellis referred to a letter dated April 12, 2010 from Daniel J. EDEN TOWN BOARD RESOLUTION COUNTY BUDGET FUNDING FOR MAINTENANCE OF COUNTY ROADS

WHEREAS, County roads are critically important to municipalities, especially in driving from one municipality to another; and

WHEREAS, in recent years the County roads have not been appropriately maintained often because of cutbacks in funding in the County Budget; and

WHEREAS, potholes, rough roads and poor shoulders often cause excessive wear and tear to individual cars and trucks and thus excessive repair costs for individual drivers to absorb; and

WHEREAS, well maintained roads reflect positively on local municipalities as well as the County Government for visitors/tourists visiting our area;

NOW, THEREFORE IT IS RESOLVED that the County Legislature is urged by the Eden Town Board to provide the funds required by the County to properly repair and maintain their roads as they exist in our various municipalities; and

BE IT FURTHER RESOLVED that the County Legislature requires a longer term County Master Plan for repair and most importantly maintenance of roads tied to appropriate funding in the County Budget.
