Supervisor Nellis read the report from Jack Rigley, Eden Fire Chief requesting adding Michael Hart to the active roster of the Eden Fire Department No. 1 pending his physical and background check.

Supervisor Nellis read the report from Jack Rigley, Eden Fire Chief requesting adding Andrew Huber to the active roster (he is currently a member on inactive status).

Supervisor Nellis read correspondence from Ron Maggs, Off-Road Drainage Committee Chairperson recommending that the Town Board approve the following project that the committee has agreed upon:

1. Project 2011-03; 2611 West Church Street – to clean from West Church to Ryther Creek. The Town will contribute up to \$300 towards the rental of a machine and the homeowner will operate and do all necessary work.

**1.** <u>Setting of Public Hearing date for Proposed Local Law on Peddlers and Solicitation</u>

Supervisor Nellis requested setting a Public Hearing for Proposed Local Law #3 Amending Chapter 153 of the Code of the Town of Eden to require criminal history inquiries for applicants seeking a peddler's license in the Town of Eden.

2. Approval of specifications for RFP on new Town-Wide Garbage Collection

Supervisor Nellis presented to the Town Board the Contract Documents for Collection, Hauling and Disposal of Mixed Municipal Solid Waste and Specified Items and Materials and Collection, Hauling and Processing of Recyclables.

Supervisor Nellis stated that this material is to be reviewed and a Public Hearing will be set at the next Town Board Meeting.

#### 3. Blacktop work on Town Hall Parking Lot

Supervisor Nellis read the following correspondence from Ron Maggs, Highway Superintendent regarding the 2011 parking lot sealing schedule:

"The Library and Town Hall parking lots are due to be sealed this year. The Library is applying for a grant for upgrades to their parking lot and the Town Hall parking lot is in need of repairs. I am recommending that we do minor repairs to the Library and repair and repave the bad portion of the Town Hall lot. The Highway Department can provide the work with the material cost not to exceed \$10,000. The money that was set aside for sealing can help offset some of the costs for these repairs."

Supervisor Nellis then offered the following resolution:

# RESOLUTION AUTHORIZING SUPERVISOR GLENN R. NELLIS TO EXPEND FUNDS FROM THE GENERAL MAINTENANCE RESERVE FUND OF THE TOWN OF EDEN SUBJECT TO PERMISSIVE REFERENDUM

The Town Board of the Town of Eden, duly convened in regular session, does hereby resolve pursuant to the provisions of Section 6-c of the General Municipal Law of the State of New York that the Town Supervisor of the Town of Eden be and is hereby authorized and directed to transfer from the General Maintenance Reserve Fund of the Town of Eden to the Town Hall Contractual Expenses Account A1620.4, a sum not to exceed \$10,000.00 from said Reserve Fund for repairs to both the Library and Town Hall Parking Lots.

This resolution shall be subject to a permissive referendum, as permitted by law.

**MOTION** was made by Supervisor Nellis to approve the resolution as presented, subject to permission referendum, which is 30 days, starting at tonight's meeting; seconded by Councilwoman Pew; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.
