Call To Order:

Supervisor Nellis called the Regular Meeting of the Eden Town Board to order at 7:30 P.M.

Supervisor Nellis led the assembly in the Pledge of Allegiance to the flag followed by a moment of silence.

Petitions:

Michele Ambor-Hutz presented petitions relating to the previous petitions that were presented at the December 27, 2012 Town Board meeting. They were forwarded to Glenn Nellis, Supervisor.

Supervisor Nellis stated that he has met with the Eden Central School, State and County regarding the situation and discussed brighter lights, reflectors on signs and a warning sign that is active from 7 - 8:30 a.m.

3. Amend Garbage Rate

Supervisor Nellis read correspondence from Ann Knack regarding an Amendment to the 2013 Town Budget – Refuse and Garage. The final roll submitted by the Assessors showed that the Town had a total of 2995 garbage units rather than the 3000 units initially reported to her by their office. Therefore, instead of the Town collecting \$450,000 in garbage and refuse taxes, we will only be collecting \$449,250.

MOTION was made by Supervisor Nellis to approve the amended 2013 garbage and refuse total tax from \$450,000 to \$449,250 and the total tax to be collected \$3,530,571.29; seconded by Councilman McLaughlin; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

4. Schedule of Fees - schedule Public Hearing
