## 2. Setting up Public Hearing for new Local Law on Commercial Cat Kennels

# 3. Proclamation on 50<sup>th</sup> Anniversary of Eden Corn Festival

Supervisor Nellis read the following resolution:

PROCLAMATION 50<sup>TH</sup> ANNIVERSARY EDEN CORN FESTIVAL **WHEREAS,** August 2013 serves as the 50<sup>th</sup> Anniversary of the beginning of the Eden Corn Festival, one of the premier summer activities in all of Western New York; and

**WHEREAS**, the success of the Festival over the many years has relied heavily upon the many individual volunteers and volunteer organizations in our town that has allowed our community to sustain the Festival; and

**WHEREAS,** in recent year, annually over 120,000 people from Eden, Western New York, and beyond have made this event probably the most significant rural event in New York State; and

**WHEREAS**, while the Festival celebration highlights the corn grown in our community, the event does serve to celebrate agriculture in general, and all produce grown here which has allowed the history of farming in Eden to establish a rich tradition of rural life for over 200 years; and

**WHEREAS**, the annual event could not have sustained itself without the leadership of the Eden Corn Festival Committee as well as the many individual volunteers and volunteer organizations that have an on-going commitment to the Festival. We say to them "a job well done!"

**FINALLY,** we wish to thank all those individuals and families that have attended and continue to attend the Eden Corn Festival. "We thank you all and hope to see you again in August 2014".

# 8. Resolution Designating Town Clerk to receive Notice of Claim

Supervisor Nellis read the following resolution:

# RESOLUTION DESIGNATING TOWN CLERK AS PERSON TO WHOM THE SECRETARY OF STATE SHOULD FORWARD ANY NOTICE OF CLAIM FOR THE TOWN OF EDEN

WHEREAS, General Municipal Law §53 was amended permitting notice of claims against public corporations to be served on the New York Secretary of State as of July 15, 2013; and

**WHEREAS**, if served, the Department of State will forward the notice of claim to the person designated by the public corporation to receive the notice of claim; and

WHEREAS, public corporations are required to file a Certificate of Designation of Notice of Claim with the New York State Department of State, designating the New York Secretary of State as their agent for service of notices of claim.

IT IS THEREFORE RESOLVED, that the Town of Eden designates Town Clerk, Mary Jo Hultquist, as the person to whom the Secretary of State should forward any notice of claim for the Town of Eden with regard to the amendment of General Municipal Law §53, permitting notices of claim against public corporations to be served on the New York Secretary of State; and

**IT IS FURTHER RESOLVED,** that Town Supervisor, Glenn Nellis, is authorized to file such designation with the Secretary of State.

**MOTION** was made by Councilwoman Pew to approve the resolution as presented; seconded by Councilman McLaughlin; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

**NOTE:** William Trask, Town Attorney added that this is a personal appointment and when the person in the position of Town Clerk is changed, by resignation or election, a new appointment would be required.

## 9. Resolution Keeping the Cornell Local Roads Program

Supervisor Nellis read the following resolution:

# RESOLUTION KEEPING THE CORNELL LOCAL ROADS PROGRAM

WHEREAS, since 1951 the Cornell Local Roads Program has been providing technical assistance and training for local highway officials through Cooperative Extension; and

**WHEREAS**, effective September 30, 2014 the College of Agriculture and Life Sciences at Cornell has decided to terminate the Local Technical Assistance Program which is the outreach program of the Cornell Local Roads Program; and

**WHEREAS**, this decision by Cornell is apparently based on the program being judged as no longer being a priority for the College of Agriculture and Life Sciences; and

**WHEREAS**, yet, this program is acknowledged within the College to be valuable, meeting a need and doing a good job; and

**WHEREAS**, all local highway officials are aware of the value of the program in providing technical assistance and meeting ongoing needs for training.

**NOW THEREFORE BE IT RESOLVED** that the Eden Highway Department and Eden Town Board strongly urge reversal of this decision by the College of Agriculture and Life Sciences; and

**BE IT FURTHER RESOLVED,** that we ask other local highway official colleagues to join us in seeking this reversal in a timely way since the New York State Department of Transportation solicits every five years proposals to maintain the Local Technical Assistance Program which current agreement expires on September 30, 2014.

**FINALLY,** let is be known that this Local Roads Program provides the Cornell University, our land grant University, and specifically the College of Agriculture and Life Sciences, the opportunity to directly impact local governments in New York State by applying their expertise to local road issues.

**MOTION** was made by Councilman McLaughlin to approve the resolution as presented; seconded by Councilwoman Pew; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.
