#### **New and Unfinished Business:**

#### 1. Policy of Workplace Violence

Councilwoman Pew read the following policy statement:

# TOWN OF EDEN MUNICIPALITY WORKPALCE VIOLENCE PREVENTION POLICY STATEMENT

The Town of Eden Municipality is committed to the safety and security of our employees. Workplace violence presents a serious occupational safety hazard to our agency, staff and clients. Threats, threatening behavior, or acts of violence against employees, visitors, guests, or other individuals by anyone on Town of Eden Municipality property will be thoroughly investigated and appropriate action will be taken, including summoning criminal justice authorities when warranted. All employees are responsible for helping to create an environment of mutual respect for each other as well as clients, following all policies, procedures and program requirements, and for assisting in maintaining a safe and secure work environment.

This policy is designed to meet the requirements of NYS Labor Law 27b and highlights some of the elements that are found within our Workplace Violence Prevention Program. The process involved in complying with this law included a workplace evaluation that was designed to identify the workplace violence hazards our employees could be exposed to. Other tools that were utilized during this process included establishing a committee made up of management and Authorized Employee Representatives who will have an ongoing role of participation in the evaluation process, recommending methods to reduce or eliminate the hazards identified during the process and investigating workplace violence incidents or allegations. All employees will participate in the annual Workplace Violence Prevention Training Program.

The goal of this policy is to promote the safety and well being of all people in our workplace. All incidents of violence or threatening behavior will be responded to immediately upon notification. The town of Eden Municipality has identified response personnel that include a member of management and an employee representative. If appropriate, the Town of Eden Municipality will provide counseling services or referrals for employees.

All Town of Eden Municipality personnel are responsible for notifying the contract person designated of any violent incidents, threatening behavior, including threats they have witnessed, received, or have been told that another person has witnessed or received.

**WHEREAS,** after comparing the thresholds in 6 NYCRR 617.4 and 5, the Town Board has determined that the proposed project is an Unlisted Action, and

**WHEREAS**, after examining the EAF, the Town Board has determined there are no other involved agencies on this matter.

**NOW, THEREFORE BE IT RESOLVED** that the Town Board declares itself Lead Agency for review of this action.

**BE IT FURTHER RESOLVED** that a Determination of Significance will be made at such a time as all reasonably necessary information has been received by the Town Board to enable it to determine whether the action will or will not have a significant effect on the environment.

# 4. Plow Contract

Supervisor Nellis referenced the following correspondence:

To: John C. Loffredo, P.E., Commissioner of Public Works, County of Erie From: Frederick J. Piasecki, Jr., President, Town Highway Supt. Assoc. of Erie County

"Dear Mr. Loffredo: First of all, the Town Highway Superintendents Association of Erie County, Inc. along with the Supervisors Committee representing the Towns, has presented to you our offer of a contract for a three-year term with a 5% per lane mile, per year increase for (2014-2016) snow Plowing, with each Town. Also, as you should recall at the first negotiation meeting Robert Keating (Director of Budget and Management – Erie County) indicated that the 5% increase was a fair and reasonable rate, and also indicated that the monies for the Snow Plowing were in the County Budget. This is the realistic offer you should be dealing with, as this percentage reflects our costs increases and not the one percent increase you sent out to the Towns.

Secondly, the issue of Public Safety is at the forefront with all the Highway Superintendents and Supervisors of the Towns. We know that Erie County does not have the resources to plow these roads. Since the current contract has expired (08-31-13) and there is no contract, we the Towns cannot legally put a plow down on roads that we do not even own. These roads belong to Erie County and it is the County Executive's responsibility to plow them.

Mark Polocarz, our County Executive, and also you, Mr. Loffredo, are playing a dangerous and risky game with the lives and safety of all the people across Erie County."

Discussion ensued and it was determined by Ron Maggs, Highway Superintendent that it could be a problem but there is time and they will wait for a reply from the County.

## 5. Schedule of Budget Hearings

Supervisor Nellis stated that budget sessions have been scheduled with Department Heads.

## 6. Eden Evans Center Road

Supervisor Nellis referenced the following correspondence:

To: John J. Mills, Erie County Legislator, 11<sup>th</sup> District From: John Loffredo, P.E., Commissioner of Public Works

"Dear Legislator Mills: I recently received a Certified Resolution, dated June 12, 2013, from the Eden Town Board concerning the condition of Eden-Evans Center Road.

As the County's Commissioner of Public Works, the condition of our County's roads and bridges is a deep concern of mine. As you know, Erie County has approximately 2,400 lane miles of roads (1,200 center lane miles), which is more than the states of Delaware, Rhode Island and Hawaii. For 2013, County Executive Mark Poloncarz has authorized the Division of Highways to conduct over \$34 million in road and bridge projects for approximately 60 projects in 17 municipalities across Erie County, a number of which are in the 11<sup>th</sup> Legislative District.

According to the new 2013 Greater Buffalo Niagara Regional Transportation Council's ("GBNRTC") biennial survey, Eden-Evans Center Road from Versailles to Schriner Road is rated in "Poor" condition (rated 5 on a scale of 1-10, with 10 being "Excellent"). This section of road is approximately 3 center line miles in length. Unfortunately, there are a total of 143.9 center line miles of roads in Erie County that are rated as "Poor" or worse condition. I estimate it will cost approximately \$107 million to repair all of these "Poor" or worse rated roads.

In 2005, there were 219.5 center line miles of roads rated in "Poor" condition. Since that time, a total of \$143 million in State, Federal and County funds has been spent on repairing Erie County roads and bridges. To date, this has resulted in a 75.6 center line mile reduction in the total amount of roads rated "Poor" or less.

As you know from prior testimony in legislative committee and caucus, we prioritize roads based on their condition as rated by GBNRTC and traffic count. The

Department of Public Works continues to work to address our aging infrastructure, but the needs are great and funding is limited.

Since this is my third tenure as Commissioner of Public Works serving my third County Executive, I know that previous legislators and administrations have worked together and tried to solve the highway funding problem. Unfortunately, there is still some work to do. The County Legislature's actions in the 2013 Budget are a further complicating factor necessitating fiscal restraint on my department.

In conclusion, should unanticipated funds become available in 2013; we will certainly consider Eden-Evans Center Road for rehabilitation, as we will for other roads throughout the County. The Department of Public Works is committed to improving as many miles of roads and bridges as possible despite financial constraints. Further, our Division of Highways staff will continue to monitor Eden-Evans Center Road, and make urgent and necessary repairs as they develop."

# RESOLUTION AUTHORIZING APPLICATION FOR FUNDS FROM THE 2013-2014 JUSTICE COURT ASSISTANCE PROGRAM

**RESOLVED** the Eden Town Board hereby authorizes Town Justice Michael Cooper to file an application for a Walk-Through Metal Detector, which costs approximately \$4,513.00 from the New York State Office of Court Administration for the 2013-2014 Justice Court Assistance Program (JCAP) Grant.

## 11. Standard Work and Reporting Resolution

## 12. Review/Approval Trident Insurance

Supervisor Nellis requested Trident Insurance be ratified as the Town of Eden Insurance Company at a total cost of \$88,700.00, which is a 3% increase over last year. Supervisor Nellis stated that he would continue to drive that figure down.
