## 2. <u>Presentation by Mark Cavacolli of CRA (Town Engineers) on timetable for</u> work plan regarding Town of Eden and ECWA Water System Consolidation

Mark Cavacolli reported on the Town of Eden and Erie County Water Authority Water System Consolidation project. Mr. Cavacolli described the program work plan.

The Town of Eden has received a \$25,000 grant, which is half of the cost of the feasibility study, which needs authorization for Supervisor Nellis to sign.

### 6. MS4 Annual Report

## 9. Eden Planning Board request for CEO attendance at Planning Board Meetings

Deputy Supervisor Pew read the following correspondence:

"At the most recent Planning Board meeting, April 29, 2014, the board had a discussion about our Code Enforcement Officer's (CEO) attendance at our meetings. Our board was in unanimous agreement that the CEO is an integral

resource upon which the Planning Board relies, during certain meetings, for technical input and Code compliance context. The Planning Board hereby requests that the CEO be in attendance for those meetings when it is deemed necessary by the Planning Board. Due to our requirement to comply with the Public Meetings Law, our agenda is established two weeks prior to our meeting. At that time, based upon those particular agenda items, the chairman of the Planning Board will determine if the CEO's presence is required. If so, a written memo shall be sent to the Town Board at that time requesting the CEO to attend. Hopefully this procedure will be sufficient for the Town Board to make any necessary arrangements to provide for the CEO's attendance at those meetings."
