All reports are on file in the Town Clerk's office.

Matthew Colvin, Eden Fire Chief requested \$1,000.00 to match a grant from NYSDEC if awarded. This grant is to purchase portable radios and a chain saw. It is a 50% match with a maximum award of \$1,000.00.

New and Unfinished Business:

1. <u>Bid Recommendation for Green Street and Depot Street Water System</u> Improvements

Mark Cavacolli, CRA Infrastructure and Engineering, Inc. requested a discussion at Executive Session regarding the bids received for the Green Street and Depot Street Water System Improvements. Only 2 (two) bids were received and they were extremely high and over-budget.

2. Ratification of Sunday work on National Fuel Project

Supervisor Nellis read the following:

TOWN BOARD RATIFICATION ON NATIONAL FUEL PROJECT IN EAST EDEN

At the request of National Fuel and after discussion with their project engineer, the Eden Town Board is voting to ratify permission under Section 146-8 of the Eden Town Code, which states hours of operation to be 7 a.m. to 7 p.m. weekdays to be allowed to have limited work crews perform work on Sundays in August and September to complete gas line replacement in the vicinity of 7889 East Eden Road, with the further condition that the truck noise be kept to a minimum, including limiting "back-up alarms" used.

MOTION was made by Supervisor Nellis to approve the above-referenced ratification on National Fuel project in East Eden; seconded by Councilwoman Pew; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

3. <u>Ratification giving Superintendent of Highways permission to fix certain property damage</u>

MOTION was made by Supervisor Nellis to authorize the Town of Eden Superintendent of Highways, Ronald Maggs, to repair damage to lawns located at 8463 N. Main Street and 8473 N. Main Street, which were slightly rutted up by emergency vehicles during an emergency response incident on Maple Avenue on July 3rd and 4th, 2014; seconded by Councilwoman Pew; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

4. <u>Presentation by Chamber on Special Committee set up to discuss the future enhancement and common vision of the Hamlet of Eden</u>

5. <u>Correcting Resolution on close out of Schoolview Waterline Replacement Contract</u>

Supervisor Nellis read the following resolution:

CORRECTING RESOLUTION

FOR

CLOSING SCHOOLVIEW DRIVE WATERMAIN REPLACEMENT PROJECT TOWN OF EDEN, EDEN TOWN BOARD August 11, 2014

Original Resolution July 9, 2014

WHEREAS, on July 9, 2014, the Eden Town Board adopted a Resolution purporting to "close" the Schoolview Drive Watermain Replacement Project, and

WHEREAS, subsequent to the adoption of said resolution, it was determined that there was an error in the balance remaining for this project, partially due to some unpaid

project expenses which were not reflected in the closing figures contained in such resolution, and

WHEREAS, the Eden Town Board has received satisfactory documentation confirming that all work on the Schoolview Drive Water Main Replacement Project is completed and has been accepted upon recommendation of project engineers and the Town of Eden seeks to formally close this project.

NOW, THEREFORE, it is hereby

RESOLVED, that the Eden Town Board does declare the Schoolview Drive Water Main Replacement Project as "closed", and it is further

RESOLVED, that the Eden Town Board does hereby report the sum of \$134,039.28 as the balance remaining on the Schoolview Drive Water Main Replacement Project to be used for debt, and it is further

RESOLVED, that the Eden Town Supervisor be permitted to sign any required documentation with regard to the closing out of the Schoolview Drive Water Main Replacement Project.

MOTION was made by Councilman Krycia to accept the resolution as presented; seconded by Councilman McLaughlin; All "Ayes"; Opposed? – None; Abstain? - None; Motion carried.

6. Discussion and Approval Resolution on repair of Eden Library Floor

Supervisor Nellis read correspondence from Phil Muck, Vice President and Trustee of Eden Library, regarding a tripping hazard at the Eden Library. As patrons enter the reading room from the east entrance of the library, the tile floor area to the carpeted flooring currently has about a two-inch ridge due to building settling. This is a hazard that could cause someone to trip and fall with the possibility of injury.

Supervisor Nellis, Mr. Maggs and Scot Christiansen have made an inspection of the area and have come to a consensus that the floor rug be rolled back three to four feet to expose the problem and grind down the ridge. In order to meet handicap accessibility requirements this should be ground down to allow for one-inch rise for every 12 inches of incline.

Five construction and/or concrete contractors have been contacted and three companies were called regarding the rug roll back and replacement.

At a special meeting of the Eden Library Trustees on August 5, 2014 a motion was made to accept the bids for the concrete work from Brockman Brothers, Inc. at a cost of \$2,295.00 (bid memo attached) and carpet floor rollback and replacement from Rick's Decorator Carpeting, at a cost of \$300.00 (verbal agreement).

MOTION was made by Supervisor Nellis, after a brief discussion with William Trask, Town Attorney, based on the recommendation of the Eden Library Trustees, to accept the bid from Brockman Brothers, Inc. at a cost o \$2295.00 and Rick's Decorator Carpeting at a cost of \$300.00; seconded by Councilwoman Pew; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

7. Approve purchase of hoses for East Eden Fire

This agenda item was tabled to be discussed at a future town board meeting.

8. <u>Informational only – Liquor License renewal for Four Corners Café</u>

A Liquor License Renewal for Four Corners Café was received and filed.

9. Part-time Public Safety Dispatcher

Supervisor Nellis read correspondence from Michael Felschow, Chief of Police recommending Kenneth Heary as a part-time Public Safety Dispatcher.

MOTION was made by Councilwoman Pew to appoint Kenneth Heary as a part-time Public Safety Dispatcher at a rate of pay of \$10.92/hour; seconded by Councilman Ventry; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.
