- 1. Regular meetings of the Eden Town Board will be held on the second Wednesday of each month starting at 7:30 P.M. Additional meetings will be held on the fourth Wednesday of each month as needed.
- 2. The official newspaper of the Town of Eden will be <u>"The Sun"</u> located in Hamburg, New York and as an alternate, the <u>"Buffalo News"</u>.
- 3. Surety Bonds will be carried as follows:

- 4. Mileage reimbursement will be \$.45 per mile while using personal vehicles on Town business, authorized in advance.
- 5. Copies of adopted minutes will be on file at the Eden Library, the Town Clerk's office and the Town of Eden Website, <u>www.edenny.gov</u>.
- 6. Appoint Key Bank, M & T, Evans Bank and Chase Bank and other institutions as deemed appropriate by the Board, as banks for deposits, checking and investments.

- 5. Town Clerk, Mary Jo Hultquist \$37,206.00 yearly, to be paid bi-weekly. The Town Clerk will also receive remuneration as school tax collector for the 2015-2016 school year \$7,669.00.
- 6. Highway Superintendent, Ronald Maggs at \$71,181.00 yearly, to be paid biweekly.

The salary of the full-time Bookkeeper will be \$37,309.00 yearly, to be paid bi-weekly.

The rate of pay for part-time highway employees will be \$12.00 per hour, to be paid biweekly.

Re-appoint Dave Rice Fire Inspector for structural fires at \$69.00 per occurrence.

Appoint Diane Herzog part-time secretary to the Code Enforcement Officer for five (5) hours per week at \$13.33/hr. to be paid bi-weekly.

The Chairman of the Assessment Board of Review is to be paid \$125.00 yearly and the other members of the Assessment Board to be compensated \$85.00 each yearly. A secretary, if needed, will be compensated \$200.00 per year.

Deputy Town Clerk Heather Ohmit will be paid \$12.39 per hour. Deputy Town Clerk Cynthia Ciesielski will be paid \$12.03 per hour. The hours and salaries of the Town Clerk's office shall not exceed a total of 1,404 Deputy Clerk hours or \$17,245.00 for the year.

Appoint Mary Jo Hultquist, Registrar, at a rate of \$3,647.00 yearly, to be paid monthly.

Appoint William Sickau part-time custodian at 40 hours per month at \$14.22/hr. to be paid monthly.

Appoint Raymond Zabron, part-time Dog Control Officer, at an annual salary of \$14,943.00, to be paid monthly.

Appoint Maureen Zabron, part-time Dog Control Officer's secretary at an annual salary of \$3,181.00, to be paid monthly.

Appoint Susan Brass, Recreation Director at \$22,447.00 yearly, to be paid monthly.

Appoint Scot Christiansen, Recreation Working Crew Chief, at \$24.47/hr., to be paid biweekly.

Appoint Lisa Sargent as Exercise Instructor, to be paid \$650.00 per 6-week session.

Appoint Cynthia Kugler, secretary to the Highway Superintendent at \$14.06 per hour for 40 hours per week, to be paid bi-weekly and secretary to the Off-Road Drainage Committee at \$25.00 per meeting.

Kim Soda, Full-Time Police Dispatcher will be compensated \$43,622.00 for the year, to be paid bi-weekly.

Part-time Police Officers will be paid \$18.64 per hour for Day Shifts, not to exceed 2285 hours and \$42,592.00 and \$19.83 per hour for Night Shifts, not to exceed 1000 hours and \$19,830.00 not to exceed a total expenditure of \$62,422.00 for all part-time officers for the year.

MOTION was made by Councilman McLaughlin to enter into a contract with Joseph Ghosen, to serve as GIS Consultant for the 2015 at \$6,000.00 yearly, to be reimbursed \$500.00 per month; seconded by Councilman Ventry; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

MOTION was made by Councilman McLaughlin to designate Lisa Winter, Bookkeeper, to oversee the services provided to the Town by Drescher and Malecki; seconded by Councilman Ventry; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

Reaffirmation of the Town's Procurement and Investment Polices:

Both are on file in the Town Clerk's office; seconded by Councilman Ventry; All – "Ayes"; Opposed? – None; Abstain? – None; Motion carried. **MOTION** was made by Councilman McLaughlin to appoint CRA Engineering as our engineering firm of record providing Retainer Services, an estimated 6-8 hours per month, for a yearly sum of \$4,500.00, to be paid semi-annually and \$3,000 as a placeholder for General Municipal Engineering Support Services and to authorize Supervisor Glenn R. Nellis to execute said contract as prepared by CRA Engineering; seconded by Councilman Ventry; All "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

MOTION was made by Councilman Krycia that the daily meal allowance for the Association of Towns Meeting held in New York City will be \$40.00 a day and the hotel stay limited to three nights for this annual meeting.
