New and Unfinished Business:

1. Resolution/Action on proposed home for the developmentally disabled at corner of Jennings Road and East Church Street

Supervisor Nellis read the following resolution:

RESOLUTION OF EDEN TOWN BOARD OBJECTING TO THE ESTABLISHMENT OF AN INDIVIDUAL RESIDENTIAL ALTERNATIVE FACILITY (GROUP COMMUNITY RESIDENCE) AT 8621 JENNINGS ROAD IN THE TOWN OF EDEN DATED JULY 8, 2015

WHEREAS, on June 4, 2015, the Town of Eden ("Town") received a letter dated May 27, 2015 from Community Services for the Developmentally Disabled ("CSDD") notifying the Town of CSDD's plans to develop one Individual Residential Alternative community residence at a vacant site identified as 8621 Jennings Road in the Town of Eden, and

WHEREAS, on June 24, 2015, the Eden Town Board held a public information session at which Mindy Cervoni, Vice President of Programs and Chief Operating Officer of CSDD was given an opportunity to provide information and answer questions about the proposed group community residence, and

WHEREAS, during such public information session the representative from CSDD was informed of many concerns raised by the public and by Town officials about the proposed site not being safe or appropriate for development as a group community residence due to the existence of a high pressure natural gas pipeline on the proposed site, the lack of sewers, sidewalks and public transportation and the incidence of traffic problems at the intersection where the proposed site is located, and

WHEREAS, the representative from CSDD acknowledged during the session that facilities such as the one proposed place additional burdens upon Police, Fire and other local emergency services because of the incidents of responses which must be made to such facilities, frequently due to false alarms and the representative also acknowledged that CSDD would not rule out the placement of individuals with criminal histories, such as sex offenders, at this site, and

WHEREAS, the Eden Central School District School Board has recently taken action indicating its opposition to the proposed siting of this facility, and

WHEREAS, it is undisputed that the Town of Eden already has a number of similar facilities sited within the Town.

NOW, THEREFORE IT IS

RESOLVED that the Eden Town Board, on behalf of the entire Eden community, objects to the proposed site development and hereby puts CSDD on notice that the proposed site is unsafe and inappropriate for such development due to the existence of a high pressure natural gas pipeline on the proposed site, the lack of sewers, sidewalks and public transportation and the existing traffic problems in proximity to this currently undeveloped site. Additionally, the site appears to be an archeologically sensitive area, as defined by the State Historic Preservation Office and the project appears to be a Type 1 Action under the State Environmental Quality Review Act (SEQR) as a non-agricultural use within Eden #2 Agricultural District and is contrary to Eden's Farmland Protection Plan, and it is further

RESOLVED, that the Eden Town Board objects to the proposed site being developed as a group community residence because it finds that the establishment of the facility described by CSDD would result in an over-concentration of community facilities or similar facilities licensed by other agencies of state government in the area in proximity to the proposed site such that the nature and character of the area would be substantially altered, and it is further

RESOLVED, that, upon adoption, copies of this resolution be immediately sent to CSDD and to the Office for People with Developmental Disabilities, Acting Commissioner Kerry A. Delaney, 44 Holland Avenue, Albany, NY 14229 (in accordance with the requirements of Section 41.34 of the Mental Hygiene Law of the State of New York) with informational copies being sent to N.Y.S. Assembly Member, Hon. David DiPietro, and the N.Y.S. Senator, Hon. Patrick Gallivan.

MOTION was made by Councilwoman Pew to approve the resolution as presented; seconded by Councilman Krycia; All "Ayes"; Opposed? – None; Abstain? – None;

Comments: William Trask, Town Attorney explained that the next step would be for Community Services to do nothing, abandon their proposal to develop this site. They have the option to request a hearing from the office for people with Developmental Disabilities, a State Agency that licenses these group homes. If they do make that request, it would be an expedited process to schedule the hearing by the commissioner of that office within 15 days. If a hearing is scheduled it would be held at the Town Hall.

2. Resolution naming July 30, 2015 in memory of Clem and Mary Crowe Family

PROCLAMATION
IN MEMORY OF CLEM AND MARY CROWE
AND THE CROWE CLAN
DESIGNATING THURSDAY, JULY 30, 2015
IN HONOR OF THIS FAMILY

WHEREAS, from 1948 through 1979 Clem and Mary Crowe lived at 9411 Sandrock Road with their 10 children, making them a well-known family within the Town of Eden; and

WHEREAS, Mary Crowe was prominent in her own right, being nominated by the Eden Woman's Republican Club and ultimately selected as 1971 New York State Mother of the Year and being the first woman in her family to attend college and earn her degree from Purdue University in 1924; and

WHEREAS, Clem Crowe was a famous sports figure as a member of the renowned Seven Mule Team playing for famed Notre Dame Football Coach, Knute Rockne and as captain of the Notre Dame Football team in 1925, as a multiple All-American in both football and baseball and as a college and professional football coach for a number of teams including a stint as head coach of the Buffalo Bills in 1949; and

WHEREAS, upon Clem and May Crowe's passing they left a trust fund for their 10 children with the proviso that the family gather every 3 years, a reunion that now includes over 100 family members of all ages and from all points of the United States; and

WHEREAS, the Crowe Family is coming home to 9411 Sandrock Road on Thursday, July 30, 2015, to honor the 7 surviving Crowe children – Joanne, Katy, Jim, Ann, Ellie, John and Mike and in memory of the deceased Crowe children, Richard, Mary Rita and Clement Patrick.

NOW, BE IT RESOLVED, that the Eden Town Board welcomes the Crowe's home to Eden and duly designates July 30, 2015 as Crowe Family Day in the Town of Eden for all residents to recognize this prominent family and its descendants.

3. Resolution calling for a hearing on the proposed revocation of a Special Use Permit Issue to Renee Adams

RESOLUTION CALLING FOR A HEARING ON THE PROPOSED REVOCATION OF A SPECIAL USE PERMIT ISSUE TO RENEE ADAMS

WHEREAS, the Eden Town Board originally issued a special use permit to Renee Adams ("permittee") on August 13, 2008, allowing her to operate a dog kennel at 3424 Hickman Road, Eden, New York, subject to certain conditions contained therein, and

WHEREAS, such special use permit has been renewed annually, subject to revocation if such conditions are not met, and

WHEREAS, a recent report from the Dog Control Officer has determined that the permittee is in violation of one or more conditions and has failed to correct such violations and the Eden Town Board intends to revoke such special use permit,

NOW, THEREFORE IT IS

RESOLVED, the Eden Town Board will hold a hearing on August 12, 2015 at 8:00 p.m. local time during the regularly scheduled meeting of the Eden Town Board, giving the permittee an opportunity to appear and be heard on the proposed revocation of the said Special Use Permit issued to Renee Adams, Dog Kennel, 3424 Hickman Road, Eden, New York failure to meet all conditions of the said Special Use Permit, including, but not limited to, condition number 5, which prohibits dogs exceeding 16 pounds from being on the premises, and it is further

RESOLVED, that permittee shall be provided notice of such hearing by first class mail sent to her last known address, and it is further

RESOLVED, that the Eden Town Board reserves the right to make a final decision regarding the proposed revocation of such special use permit following such hearing.

Ann Marie Tobin, East Church Street, as a new homeowner next to the proposed group home site, thanked the neighbors for speaking on behalf of the homeowners in the area.
