Department reports for the month of May, 2016 were presented by Matthew Colvin, Eden Fire Chief; Scott Hunter, East Eden Fire Chief; Michael Felschow, Eden Police Chief; Ray Zabron, Dog Control Officer; Ronald Maggs, Superintendent of Highways; William Trask, Town Attorney; Mary Jo Hultquist, Town Clerk; Supervisor Hartman for Mark Clark, Zoning Code Enforcement Officer; Supervisor Hartman for Susan Brass, Recreation Director; Robert Pietrocarlo, Chairman Board of Assessors and Supervisor Hartman for Joe Ghosen, GIS Consultant. All reports are on file in the Town Clerk's office.

Ron Maggs, Highway Superintendent, as Chairman of the Off-Road Drainage Committee, recommending the following projects:

1. Project 2016-02: Ackerman Property, to clean the ditch, from the road heading west for approximate 400' at a cost not to exceed \$1,600.

New and Unfinished Business:

1. <u>Approval of on-year contract extension with Waste Management and the</u> Town of Eden

Supervisor Hartman read the following resolution:

RESOLUTION FOR THE TOWN OF EDEN TO ENTER INTO A ONE (1) YEAR RENEWAL CONTRACT WITH WASTE MANAGEMENT OF NY LLC EFFECTIVE JANUARY 1, 2017

WHEREAS, on December 29, 2011, the Town of Eden entered into a three (3) year contract with Waste Management of NY LLC for the Collection, Hauling and disposal of Mixed Municipal Solid Waste and Specified Items and Materials and the Collection, Hauling and Processing of Recyclables, which expired on December 31, 2014; and

WHEREAS, said contract document allows the Town, at its sole discretion, to renew this contract for up to three (3) additional (1) year terms; and

WHEREAS, on September 9, 2015, the Town of Eden approved the second one (1) year extension of the original contract with amendments pertaining to Waste Management of NY LLC providing the Town of Eden with quarterly itemized reports on weights of Municipal Solid Wastes and Recyclables hauled and disposed of and also Waste Management of NY LLC providing reimbursement to the Town of Eden for all recyclable materials collected, based on a blended value formula, which is commodity based and market driven, which extension with amendments expired December 31, 2016.

WHEREAS, after several conversations with Waste Management, the Town desires to renew our current contract.

NOW, THEREOFRE, BE IT RESOLVED, that the Eden Town Board hereby agrees to renew its contract with Waste Management of NY LLC, as amended on September 9, 2015 for a third one (1) year period commencing January 1, 2017.

NOTE: Supervisor Hartman stated that the Town may be looking to increase the size of the recycle tote with the possibility of a grant to assist with that project.

5. Resolution to approve expenditure for streetlight transfer from pole #123 to #124 on Route 62

Supervisor Hartman read the following resolution:

RESOLUTION OF THE EDEN TOWN BOARD MOVING STREET LIGHTS ON MAIN STREET

WHEREAS, the Eden Town Board has received a request to increase the lighting on Route 62 over the crosswalk located near the Eden Boys and Girls Club and Eden Elementary School; and

WHEREAS, upon review by National Grid, it was determined that the street light on pole #123, Route 62 can be moved to pole #124, Route 62 at the cost to the town of \$258.30 for a customer convenience charge.

NOW, THEREFORE, IT IS RESOLVED, that the Eden Town Board does hereby approve this light change, effective June 8, 2016.

6. Approve Resolution rejecting all bids on water project

Supervisor Hartman read the following resolution:

RESOLUTION OF EDEN TOWN BOARD DATED JUNE 8, 2016 REJECTING ALL BIDS ON WATER PROJECT

WHEREAS, the Eden Town Board previously authorized advertising for bids for Water System Tank and Pump Station Improvements (hereinafter "Project"), and

WHEREAS, on May 26, 2016, bids were received, opened and reviewed by Eden's Engineer, GHD, and

WHEREAS, upon close examination of the bids between the two lowest bidders for both the General (Contract No. 1) and Electrical (Contract No. 2) Construction, it was determined that certain portions of the bidding specifications for Women and Minority Business Enterprises were inadvertently left in the bid specifications, possibly contributing to a wide price disparity between the 2 lowest bidders and raising the prospect for confusion during the bid award process and resulting in professional recommendations to re-bid the project, and

WHEREAS, upon additional review and consideration of other major construction projects currently ongoing in the Buffalo/WNY region it was felt that prospects for obtaining more favorable bidding results and cost savings would be enhanced by delaying the re-bid to a later date.

NOW, THEREFORE, it is hereby

RESOLVED, that the Eden Town Board does hereby reject all bids received for the Water System Improvement Project and it is further

RESOLVED, that said project will be re-bid at a later date to be set by further action of the Town Board.

MOTION was made by Councilman Ventry to approve the resolution as presented; seconded by Supervisor Hartman; All "Ayes"; Opposed? - None; Abstain? - None; Motion carried.

7. Workers Compensation Comparison

Supervisor Hartman stated that after consulting with Ron Miller, Evans Agency it was in the best interest of the Town to consider changing to NY Comp Alliance from the current NYSIF. It would include the same coverage as in the past and a cost savings to the Town.

MOTION was made by Supervisor Hartman to name NY Comp Alliance as the new Workers Compensation carrier commencing July 1, 2016 through June 30, 2017 at a cost of \$147,041.00; seconded by Councilwoman Wilhelm; All "Ayes"; Opposed? - None; Abstain? - None; Motion carried.

Supervisor's Report:

- 10 local businesses are participating in the Erie County Facade Program with construction beginning in the fall.
- Applied for the Technical Assistance Grant for 2017 for the Central Business District.
- Funding found through Paul DiLonardo for the update to the Comprehensive Plan
- Mortgage tax update \$10,318.66, higher than last year.

Hearing of Visitors:

Ray Klein, Maple Avenue, concerned about the condition of the property at 8522 N. Main Street and if the Town could do anything. Supervisor Hartman stated that the Erie County Health Department has been contacted and the property owners were facing fines.
