Steven Waldvogel, Town Engineer, stated that the Erie County Water Authority has approved the supporting resolution and that the application is going in and the SEQR process will begin. He should have the coordinated review and resolution, and hopes to have the draft map and plan by the August Town Board meeting.

Mr. Waldvogel gave a brief update on Kelly's Place, stating that additional information was requested from the developer by the engineers, including drainage and landscaping plans. They are still awaiting plans for other requirements for the Special Use Permit.

Worker's Compensation Plan

WHEREAS there has been proposed a "NEW YORK STATE MUNICIPAL WORKERS' COMPENSATION ALLIANCE PLAN DOCUMENT" pursuant to Section 503-a of the Workers' Compensation Law (hereinafter "the Plan") and

**WHEREAS** the Town of Eden, Town of Eden Fire District, Town of Eden Emergency & Rescue is eligible for membership in the Plan; and

**WHEREAS** the Town of Eden, Town of Eden Fire District, Town of Eden Emergency & Rescue has made an independent investigation of the Plan and review the Plan document, and has concluded that it would be in the interests of the Town of Eden, Town of Eden Fire District, Town of Eden Emergency & Rescue to participate therein; now, therefore, be it

**RESOLVED** that the Town of Eden, Town of Eden Fire District, Town of Eden Emergency & Rescue enter into membership in the Plan pursuant to Section 50 Subdivision 3-a of the Workers' Compensation Law; and be it further

**RESOLVED,** that Melissa M. Hartman be and hereby is authorized and instructed to execute the Plan's charter document on behalf of the Town of Eden, Town of Eden Fire District, Town of Eden Emergency & Rescue; and be it further

**RESOLVED,** that the custody of all joint Plan moneys by the Plan Administrator under the Plan and the same hereby is approved.

**NOW, THEREFORE, IT IS RESOLVED,** that the Eden Town Board does hereby approve the New York State Municipal Workers Compensation Alliance Plan, effective July 1, 2016.

**RESOLVED**, that this election shall become effective on July 1, 2016.
