WHEREAS, "The Hamburg Sun" newspaper, now produced by The Buffalo News, is back in circulation; and

WHEREAS, the Eden Town Board has re-declared the "Hamburg Sun" as the new official newspaper of the Town of Eden.

NOW, THEREFORE, IT IS RESOLVED, that the Eden Town Board does hereby approve this change, effective March 8, 2017.
