Supervisor Hartman stated that the Refuse/Recycling contract expires on 12/31/17 and this purchase would be made this year. The financing is already approved with the increase in refuse in the 2017 budget for the totes. By using the totes, the hauling costs would see a decrease and recycling would be picked up every other week. Replacement cost for a resident would be \$54.00 per bin, if damaged by homeowner.

# 8. Resolution awarding Waterline Improvement Project bid

**WHEREAS**, the Eden Town Board previously authorized advertising for competitive bids for the increase and improvement of facilities of the Town of Eden Consolidated Water District and Extensions consisting of the construction of certain waterline improvements to the Town of Eden Water Distribution, and

**WHEREAS,** sealed bids for such project were duly received and opened on Monday, April 3, 2017, and

**WHEREAS**, such bids have been reviewed by project engineers, GHD Consulting Services, Inc. (GHD) and GHD has determined that New Frontier Excavating & Paving,

Inc. ("New Frontier") was the low, responsible bidder at a bid of \$2,833,376.00 and GHD has recommended awarding the bid and contract to New Frontier.

#### NOW, THEREFORE, it is hereby

**RESOLVED,** that the Eden Town Board does hereby award the Waterline Improvements Contract to New Frontier at the bid price of \$2,833,376.00 and it is further

**RESOLVED,** that Town Supervisor Melissa Hartman is hereby authorized to enter into a contract with New Frontier subject to New Frontier complying with all pre-contract conditions.
