3. Resolution – 9723 New Oregon Road

Supervisor Hartman read the following resolution:

A RESOLUTION SUBMITTED BY MELISSA M. HARTMAN OF THE TOWN OF EDEN

WHEREAS, in July 2011 in recognition of the growing problem of distressed, vacant, abandoned, and tax-delinquent properties, New York State passed the Land Bank Act, as Article 16 of the New York State Not-for-Profit Corporation Law, which authorizes any Foreclosing Governmental Unit (FGU) to create a land bank to strategically acquire, improve, assemble, and sell these properties; and

WHEREAS, under this law, the buffalo Erie Niagara Land Improvement Corporation (BENLIC) was formed in May 2012 via an inter-municipal agreement among the county's four FGUs: Erie County and the Cities of Buffalo, Lackawanna and Tonawanda; and

WHEREAS, county-wide land banks have proven highly successful in Michigan, Ohio and other regions experiencing growing numbers of problem properties by supporting municipal and regional revitalization efforts by strategically acquiring, improving, assembling and selling these properties; and

WHEREAS, BENLIC (the land bank) seeks to work collaboratively with the cities, towns and villages within Erie County to address the growing problem of distressed, vacant, abandoned, and tax-delinquent properties; and

WHEREAS, the **Town of Eden**, Erie County, has recognized the need to address the growing issues of distressed, vacant, abandoned and tax-delinquent properties and is desirous of partnering with BENLIC to address this problem.

NOW, THEREFORE, BE IT RESOLVED, that the **Town of Eden**, hereby officially requests that BENLIC acquire the following property:

9723 New Oregon Road, Eden, New York 14057

; and be it further

RESOLVED, that the **Town of Eden** will complete the required Acquisition Applications for each property listed above and has attached the Acquisition Applications to this resolution; and be it further

RESOLVED, that the **Town of Eden** agrees to reimburse Erie County for the costs associated with foreclosure of this property; and be it further

RESOLVED, that the **Town of Eden** agrees to maintain each property selected by BENLIC during the time in which BENLIC holds title to the property including removal

of motor vehicles upon BENLIC property by use of municipal emergency services (i.e. police and fire department); and be it further

RESOLVED, in the event that after a period of one year from the date of BENLIC acquisition, BENLIC is unable to dispose of vacant lots which do not contain structures and which are identified herein, BENLIC retains option to transfer to the **Town of Eden**, the **Town of Eden** agrees to accept a transfer of title of all non-disposed vacant lots which do not contain structures by quit claim deed,

RESOLVED, that certified copes of this resolution will be sent to the Executive Director of the Buffalo Erie Niagara Land Improvement Corporation, the Commissioner of the Erie County Department of Environment and Planning; the Director of the City of Buffalo's Office of Strategic Planning; and the Mayors of the cities of Lackawanna and Tonawanda.

ORDER OF EDEN TOWN BOARD Pursuant to Eden Code, Chapter 90 Regarding Property Commonly Known as 8572 N. Main Street Eden, New York 14057

TO: MICHAEL HOFFMAN, designated agent for A.I.T.C.H. LLC ("Owner") 5106 Parker Road Hamburg, New York 14075

WHEREAS, the Code Enforcement Officer of the Town of Eden, Erie County, State of New York, undertook several recent interior and exterior inspections of the subject property and has filed a written report dated June 30, 2017 with the Town Board of the Town of Eden, pursuant to the provisions of the Town of Eden Unsafe Buildings and Structures Law, Chapter 90 of the Town of Eden Code, regarding the structure and improvements situated on premises reputedly owned by A.I.T.C.H. LLC and located at 8572 N. Main Street, Town of Eden, designated by Tax Map Parcel No: 238.07-1-33, and

WHEREAS, said Report deems the property to be in violation of the provisions of Chapter 90 in that the said structure is in a state of dangerous disrepair and deterioration including, but not limited to, significant damage and deterioration to the foundation resulting in sections of the foundation walls being in a state of rapid failure, together with such other interior and exterior deficiencies as are described in the Code Enforcement's Report, which is incorporated herein by reference, resulting in such structure being dangerous or unsafe to the general public and also resulting in such structure to be unfit for the purposes for which it may be lawfully used or occupied.

NOW, THEREFORE, the Town Board of the Town of Eden, after considering said report, and pursuant to the provisions of said Chapter 90, does hereby determine that the said structure and improvements located at 8572 N. Main Street, Eden, NY are unsafe and dangerous and makes the following Order:

1. ORDERED that the conditions described in the CEO's Report of the structure located at 8572 N. Main St., in the Town of Eden constitute an imminent danger to occupants and to the public requiring the immediate issuance and posting by the Code Enforcement Office of Notices prohibiting occupancy or entry except for purposes of securing the property against further deterioration and/or for purposes of evaluating measures to demolish, secure or repair the structure, and it is further Ordered

2. ORDERED that the owner of the structure located at 8572 N. Main St. in the Town of Eden, at its sole cost, take immediate steps to secure the property against unauthorized entry and to secure the property against further deterioration and, it is further

3. ORDERED that the owner promptly obtain all necessary authorizations for demolishing said structure pursuant to permit duly issued by the Town of Eden, in which case the debris and rubbish therefrom shall be properly disposed of and removed from the premises and owner shall take all steps required to secure the site and surrounding properties and public ways from damage or debris during such demolition, and it is further

4. ORDERED that such demolition must be commenced within twenty (20) days of the service on the owner of the notice required by Chapter 90 and shall be completed

within sixty (60) days of the service of this notice, unless <u>for good cause shown</u> such time shall be extended by the Town Board, and it is further

5. ORDERED that the Town Board of the Town of Eden will conduct a public hearing on August 9, 2017 at 8:00 pm at the Eden Town Hall, 2795 East Church Street, Eden, New York 14057, at which time the owner will be given an opportunity to be heard by the Town Board on the issue of why the said Order for Demolition should not be executed, and it is further

6. ORDERED that due Notice be provided to the Owner of this Order and of the authority of the Town to proceed as authorized by Eden Code Chapter 90 in the event Owner shall fail to undertake its obligations pursuant to this Order and the legal and financial penalties that may be assessed against the Owner upon its failure to comply.

Mr. Hoffman and Mr. Maruk were given an opportunity to speak at this time. They submitted answers to the Structural Condition Report that was prepared by Jesse Baker, Code Enforcement Officer. Mr. Hoffman would like to repair this property.

William Trask, Town Attorney stated that the Town Engineering Firm, GHD is reviewing the report and the Order for Demolition will remain in effect until a decision has been reached. Repairs done before would be prohibited as well as entry to the building, only by the Engineer and the Building Department.

Supervisor's Report:

- Thanks to Eden Corn Festival Committee and all Emergency Services for a successful 2017 Eden Corn Festival. Also, thanks to Ron Maggs and the Highway Department.
- The Town of Eden will be forming a safety committee with the Town and Corn Fest Committee.
- Grant update: NYS Main St, applied for a \$300,000.00 grant; Croops Mill, doing a feasibility study; Comprehensive Master Plan, working with the University of Buffalo; looking for shovel-ready manufacturing for 8800 S. Main Street. All grants are being submitted by Clark Patterson & Lee, saving the town approximately \$34,000.00.
