3. East Eden Fire Chief Delegation

Supervisor Hartman read the following:

EAST EDEN FIRE DEPARTMENT

To Whom It May Concern:

By means of this letter, I, Scott Hunter, delegate the authority herein described to the East Eden Fire Chief, on the following terms and conditions:

- 1. The First and Second assistant chiefs may review and execute, on my behalf, contracts in an amount and duration not to exceed current spending allocations set forth by the Town Board of Eden and until my replacement has been elected.
- 2. The contracts subject to this delegation are those relating to purchasing gear, vehicles, and equipment.
- 3. The effective date of this delegation is 1 January 2018 and shall run until a person is elected to replace my exiting position as East Eden Fire Chief.
- 4. The authority delegated is subject to sub-delegation without my prior and express written consent based on the aforementioned replacements of First and Second assistant chief's roles.
