Rick Kirst, East Eden Fire Chief; Michael Felschow, Eden Police Chief; Ray Zabron, Dog Control Officer; Ronald Maggs, Superintendent of Highways; Mike Quinn, GHD, Town Engineer, William Trask, Town Attorney; Mary Jo Hultquist, Town Clerk; Jesse Baker, Zoning Code Enforcement Officer; Amy Porter, Recreation Director; Robert Pietrocarlo, Chairman Board of Assessors and Supervisor Hartman for Joe Ghosen, GIS Consultant. Amy Porter, Recreation Director presented her report and gave some suggestions regarding options with the upcoming Eden Central School District re-vote and the possibility of additional costs to the Recreation Department in the event of a Contingency Budget.

Councilperson Sam for Scott Hultquist, Director of Operations for the Eden Emergency Squad requested that Ambulance #805 be declared surplus and to start the process of selling the vehicle.

7. Appoint of new Town Clerk

Supervisor Hartman read the following:

Eden Town Board appoints Emily Hawkins to the appointed position of Town Clerk effective July 14, 2018. This position will be up for a special election on Tuesday, November 6, 2018 for a one-year term. This position will then be up for election in November 2019 for a 4-year term beginning January 1, 2020.

Our current Town Clerk has the right to appoint this person as a Deputy Town Clerk for the purposes of training prior to July 14, 2018.

The salary for the Town Clerk is \$39,483.00 yearly, to be paid bi-weekly. The Town Clerk will also receive renumeration as school tax collector for the 2018-2019 school year pursuant to the agreement with the Eden Central School District in the amount of \$8,380.00.

This person will also be appointed as the Town Registrar at a rate of \$3,870.00 yearly, prorated through December 31, 2018 to be paid monthly.

MOTION was made by Councilperson Wilhelm to appoint Emily Hawkins as Eden Town Clerk, effective July 14, 2018 as above-stated; seconded by Councilperson Byrnes; "Ayes"; Ventry, Wilhelm, Byrnes, Sam; Opposed? – None; Abstain? – Hartman; Motion carried.

8. Recreation Department appointments/changes

The following recommended appointments/changes were made by Joseph Winiecki, Chairman of the Eden Recreation Department:

Kevin Armbrust as a substitute for lifeguarding, recreation and camp at a rate of \$10.65 per hour.

"It is the recommendation of the Eden Recreation Board to approve the AM Supervision Program. The Program would run from 7:30 – 9:00 a.m. from June 25th through July 31st. The cost would be \$6 per child per day regardless of the drop-off time. The supervision would include a leader with an assistant and would take place at the Elementary School location only. Children would need to be registered the Friday preceding the week that they would like to attend so that we could staff appropriately."

- Councilperson Ventry met with Glenn Nellis at the Tax Web facility, the old straw factory. They manufacture chains/straps.
- Councilperson Wilhelm stated that the Friends of the Library and EMS are still looking for volunteers.

Hearing of Visitors:

Ray Zabron stated that the increase in fees to the recreation department by the school feels like the school board is holding the residents of Eden hostage to pass the revote. It was stated that the contingent budget may not happen and a lot is NYS mandates. Councilperson Wilhelm stated that the town will find alternatives, if that happens.
