13. Proposed Local Law No. 2-2019; Flood Damage Prevention

Town Attorney Bill Trask read the following:

TOWN BOARD OF THE TOWN OF EDEN STATE ENVIRONMENTAL QUALITY REVIEW ACT (SEQRA)

Negative Declaration (April 10, 2019)

WHEREAS, the Eden Town Board is considering action relative to the adoption of Proposed Local Law No. 2- 2019, which would repeal and replace existing Chapter 114 of the Town of Eden Code with a new Chapter 114 entitled "Flood Damage Prevention" to comply with current federal and state requirements for floodplain management (hereinafter "Project" or "Action"); and

WHEREAS, the Eden Town Board previously determined that the proposed Action declared itself Lead Agency by resolution dated March 13, 2019 and a public hearing thereon was held on April 10, 2019; and

WHEREAS, the Board has taken a "hard look" at all potentially adverse environmental impacts pursuant to SEQRA.

NOW, THEREFORE, be it resolved by the Board that:

Based upon the Board's thorough and careful review of the Action, including all materials submitted in connection therewith, the Board hereby determines that the Action will not result in any significant environmental impacts and hereby issues a negative declaration for the Action pursuant to SEQRA.

REASONS SUPPORTING THE NEGATIVE DECLARATION:

- 1. <u>Air, Water, Noise, Waste, Erosion, Drainage, Site Disturbance Effects</u>: The Action will not create any permanent adverse change in the existing air quality, water quality or noise levels, nor in solid waste production, nor potential for erosion, nor promote flooding or drainage problems.
- 2. <u>Aesthetics, Agriculture, Archeology, History, Natural or Cultural</u>
 <u>Resource, Community or Neighborhood Characteristics</u>: The Action will not adversely affect agricultural, archeological, historical, natural, or cultural recourses.
- 3. <u>Vegetation, Fish, Wildlife, Significant Habitats, Threatened or Endangered Species</u>: No plant or animal life will be adversely affected by the Action.
- 4. <u>Community Plans, Use of Land or Natural Resources</u>: The Action is not inconsistent with official community plans and goals and will have no adverse effects on land-use or the use of natural resources by or in the community.
- 5. <u>Growth, Subsequent Development, etc.</u>: The Action will not induce any significant or adverse growth or subsequent development.
- 6. <u>Long Term, Short Term, Cumulative, or Other Effects</u>: The Action will not have any significant adverse long term, short term, cumulative, or other environmental effects.
- 7. <u>Critical Environmental Area</u>: The Action will not have significant impact on any Critical Environmental Area as designated in 6 NYCRR, subdivision 617.14(g).
- 8. <u>Public Health and Safety</u>: The Action will have no immediate impact upon these concerns.
- 6 NYCRR § 617.1 states that it is the intention of the SEQR regulation "that a suitable balance of social, economic and environmental factors be incorporated in the planning and decision making of State, regional and local agencies. It is not the intention of SEQR that environmental factors be the sole consideration in decision making."

This Board has considered all of the evidence submitted and has determined that the Action will not have a significant adverse environmental impact on the community.
