4. Negative Declaration SEQR for Mixed Use Design Standards and Set Public Hearing:

SEQRA NOTICE LEAD AGENCY DESIGNATION AND DETERMINATION OF SIGNIFICANCE FOR TOWN OF EDEN ZONING AMENDMENTS

Whereas, the Town of Eden Town Board has proposed amendments to the current Zoning Code for the creation of two new zoning districts for the area around the hamlet of Eden Center, implementing recommendations and goals contained within the Town's Comprehensive Plan, Cultivate Eden, adopted in 2018; and

Whereas, the zoning amendment will replace the existing General Business and Office Business Districts located within the hamlet of Eden Center, amending the zoning map and creating new development and design standards and regulations; and

Whereas, in accordance with the provisions of 6 NYCRR Part 617 (SEQRA), the project is determined to be a Type 1 Action which is subject to a coordinated review, though no other agencies have jurisdiction over legislative adoptions by the Town of Eden.

Now Therefore Be It Resolved that the Town Board hereby designates itself as Lead Agency for the proposed action pursuant to 6 NYCRR Part 617.

10. LED Lights Agreement with National Grid:

Attorney Trask explained that there are two agreements; one for the asset purchase allowing to buy the street lights on the pole in order to do the conversion and the second is the license agreement to allow the lights to stay on National Grid's utility poles for the LED light conversion.

RESOLUTION OF EDEN TOWN BOARD

WHEREAS, the Town of Eden ("Town" or "Eden") has been in discussions with Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") to acquire street lighting facilities in the town as a long-term investment that is expected to save Eden taxpayers money as a result of being switched to Service Classification No. 3 under National Grid's Tariff No. 214, and

WHEREAS, National Grid has undertaken an inventory of street lighting facilities to be acquired by the Town and has provided certain agreements which must be approved and authorized by Eden in order to allow National Grid to start the process required to obtain approval from the New York State Public Service Commission for the sale of the street lighting facilities to Eden, and

WHEREAS, the agreements have been reviewed and found to be appropriate for execution by the Supervisor on behalf of the Town.

NOW, THEREFORE, BE IT

RESOLVED, that the Town Board of the Town of Eden hereby authorizes Supervisor Melissa Hartman to execute the <u>Agreement for the Purchase and Sale of Street Lights</u> and the "Exhibit A" License Agreement for Customer-Owned Street and Area Lighting <u>Attachments to Utility Poles and Structures</u> with National Grid, and Supervisor Hartman

is further authorized to execute any related agreements, instruments or documents required to move this process forward to conclusion, and it is further RESOLVED, that copies of this Resolution be sent to National Grid and any other entity or agency which may request a copy.

13. Amend Recreation Appointments:

The Recreation Board is asking for the following changes to Summer Recreation Staff:

- Mitch Mason from Playground Assistant to Playground Leader and his wage rate from \$11.35 to \$13.00 per hour
- Brittaney Goodrich from Sports Leader Assistant to sports Leader and her wage rate from \$11.20 to \$12.25 per hour.
- Joseph LoTempio from Sports Leader to Grounds and Maintenance Crew and his wage from \$12.25 to \$11.20 per hour.

MOTION was made by Supervisor Hartman to approve the changes as read; seconded by Councilperson Byrnes; All – "Ayes"; Opposed? – None; Abstain? - None; Motion carried.

Councilperson Wilhelm noted that Joseph LoTempio stepped in to cover the grounds and maintenance crew opening to help out at the last minute and asked if there was anyway to keep his rate of pay the same based on his years of service. After discussion, Councilperson Ventry referred the question back to the Recreation Board for their review.

14. Accept Bettyann Neifer Resignation:

Supervisor Hartman stated that a letter was received from Bettyann Neifer resigning from her position of part-time court clerk effective May 15, 2019.

Supervisor Hartman thanked Bettyann for her 23 years of service to the Town of Eden.

15. Annual Unified Court System Audit:

WHEREAS, the Unified Court System of the State of New York requires that town justices annually provide their court records and dockets to their respective town auditing board, and that such records be examined and that fact be entered into the minutes of the board's proceedings.

NOW, THEREFORE, it is RESOLVED that the Town Board of the Town of Eden has received the audited Statement of Cash Receipts and Cash Disbursement for the Town Justices from Drescher & Malecki LLP, independent auditors.

16. Approval for additional Eden Court Bail Account:

Resolution for Eden Town Court to Add Additional Bank Account

WHEREAS The Town of Eden recently completed its annual internal audit, and WHEREAS Drescher & Malecki LLP completed the audit on behalf of the Town, and WHEREAS Drescher and Malecki suggest that the Town consider creating separate bank accounts for each Justice to record their bail activity in order to improve clarity of these transactions, and

WHEREAS the Justices are in agreement to this suggestion

NOW, THEREFORE, BE IT RESOLVED: The Town of Eden gives permission to Eden Court to open an additional bail account at Evans bank.

MOTION was made by Councilperson Ventry to approve the Resolution as presented; seconded by Councilperson Byrnes; All – "Ayes"; Opposed? – None; Abstain? - None; Motion carried.

Supervisor's Report:

- 11 businesses submitted applications for the Main Street Grant which are in review by the selection committee and awards will be given on May 17, 2019.

Councilperson Ventry: Off road drainage committee is a group of volunteers that walk our creeks in town and spend a great deal of time checking creeks, clearing blockages, cutting trees, etc. He thanked Ron for heading that committee.

Councilperson Sam: Spoke to the attorney working on the Fire Policy which should be completing review soon. May 23, 2019 is a joint training with Eden and East Eden which is a live burn at Chestnut Ridge.

Hearing of Visitors:

Glenn McLaughlin asked if the full time Clerk's position that the town is adding to the civil service inventory is intended to be for the Assessor's Office. Supervisor Hartman responded that the town needs to have certain positions in the civil service inventory in which the job will be part time in the Assessor's Office and part time in the Supervisor's Office thus creating a full-time position.

He then asked for clarification on the need for the additional attorney for the water project. William Trask answered that he is the primary attorney on that project however through further discussion with the Water Authority the Town agreed to get another opinion from outside counsel on some of the procedures that had been followed to date, to help us move forward with the Water Authority.

Ray Klein asked if there was anything happening with the unkept property next to Eden Seafood and Pizzeria. Supervisor Hartman responded that there is someone living at the property and the Town and Building inspector are aware and working on the issue.
