Public Comment on Mixed Use Design Standards:

Supervisor Hartman stated that three teams from the Master Plan Implementation Committee have been working on zoning up-dates for the Town. Group A specifically has been drafting a mixed-use form-based zoning for the Main Street District.

Brian Kulpa from Clark Patterson Lee briefly discussed the hybrid form-based zoning, which describes a pedestrian accessible pattern with buildings pulled to the street. This zoning will promote future development using the traditional values that can currently be seen in the existing buildings.

Supervisor Hartman asked if there was any public present wishing to comment on the zoning:

Bill Mahoney, Implementation Committee Team A, stated that the draft Mixed Use Design Standards are in line with the visions of his committee.

2. Create Civil Service Position, Lieutenant:

MOTION was made by Supervisor Hartman to approve the creation of the position Police Lieutenant, Competitive; seconded by Councilperson Wilhelm; All – "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

3. Fire Bids for East Eden and Eden Fire Departments:

MOTION was made by Supervisor Hartman to approve the Eden and East Eden Fire bid results as presented and allow Eden Fire choice of TURK Stokes Carrier pending results of demo; seconded by Councilperson Sam; All – "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

4. Discuss Light Rescue Truck for Eden Fire Department:

The Town Board and Joe Hart discussed adding a light rescue truck to the Eden Fire inventory instead of replacing the tanker which is still in good condition and does not need replacement at this time. The Board asked for an outline/analysis of the replacement schedule with two options, showing the increase in cost for the larger tank of Engine 5 vs. replacement of the tanker and addition of the Light Rescue Truck. Joe will work on a couple different scenarios and present them to the board.

Joe Hart explained the benefits of purchasing the light rescue truck:

- Current tanker is in excellent condition, body and engine in great shape and carries enough water for the needs of the Department. Eden continues to get larger tankers in surrounding districts, including the new tanker purchased by East Eden.
- Fire Police and increasing visibility
- Utilize a less expensive piece of equipment to respond to accidents, down power lines
- Winter weather: 4-wheel drive vehicle that can withstand harsher weather
- Less man power and equipment usage
- Grow RIT (Rapid Intervention Team) and enable quicker response times
- Cost is significantly less

5. Update on Eckhardt Road County Study:

Supervisor Hartman read the following results of the request for all-way stop control at the intersection of East Eden Road and Eckhardt Road, provided by Erie County Traffic Safety Engineer, Gina Wilkolaski:

"While reviewing the accident reports, it was determined that a common accident type involved drivers on Eckhardt Road failing to stop at the STOP signs before entering the intersection. This

driver error was observed by this Department during the traffic count for this study despite the presence of dual STOP signs in each direction. To further increase driver awareness of the stop control at this intersection, oversized STOP signs and dual advanced warning signs will be installed. These treatments have been used in other Erie County locations to successfully reduce accident rates. This work will be done by Erie County forces as weather and workload permits."

It was noted that this work has already been completed and the Town will request a Federal Study in the future. Supervisor Hartman thanked the Eden and East Eden Fire Department and Highway for their assistance with the removal of trees.

6. Stop DWI:

Supervisor Hartman read the following Resolution:

Whereas, the Town of Eden participated in the Stop DWI program through Erie County Department of Central Police and

Now therefore be it resolved, that the Town Board of the Town of Eden herby gives permission for Supervisor Hartman to execute said contract to convey 2018 DWI fine revenue to the Town of Eden

RESOLUTION AUTHORIZING SUPERVISOR MELISSA M. HARTMAN TO EXPEND FUNDS FROM THE GENERAL FUND RESTRICTED RESERVE FOR BUILDING MAINTENANCE

OF THE TOWN OF EDEN SUBJECT TO PERMISSIVE REFERENDUM

The Town Board of the Town of Eden, duly convened in a regular session, does hereby resolve pursuant to the provisions of Section 6-C of the General Municipal Law of the State of New York that the Town Supervisor of the Town of Eden be and is hereby authorized and directed to appropriate a sum not to exceed \$32,950.00 from the Restricted Reserve for General Building Maintenance A882.0 of the Town of Eden for the

purpose of replacing the Library roof.

MOTION was made by Supervisor Hartman to approve the resolution as read; seconded by Councilperson Wilhelm; All – "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

12. Off-Road Drainage Committee:

The following recommendation was received from Ron Maggs, Chairman, Off-Road Drainage Committee:

- **a. 2019-01:** Knoll Road (Top of Hill) to clean ditch from road heading east for approximately 1000' at a cost not to exceed \$1,000
- **b. 2019-02:** Miscellaneous town wide hand clearing and mowing in an amount not to exceed \$3,000

MOTION was made by Supervisor Hartman to approve project 2019-01 at a cost not to exceed \$1,000.00 and approve project 2019-02 at a cost not to exceed \$3,000.00; seconded by Councilperson Wilhelm; All – "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

13. Set Bid Opening Date for Consultant for Bley Road Mill Study:

MOTION was made by Supervisor Hartman to set the bid opening date for the consultant for the Bley Road Mill Study to June 28, 2019 at 2:00 PM; seconded by Councilperson Ventry; All – "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

Supervisor Hartman stated she met with the Buffalo River Keepers Organization regarding additional funding for this project. She is hopeful that the study can be increased to include the embankment, to provide access to fisherman and kayaks. Buffalo River Keepers offered to help write the grant which could decrease costs by \$17,000 if awarded.

14. Digital Towpath Code Program for Building Department:

MOTION was made by Supervisor Hartman to approve Digital Towpath programing for the Building Department in the amount of \$600.00; seconded by Councilperson Byrnes; All – "Ayes"; Opposed? – None; Abstain? – None; Motion carried.

15. Water Consolidation Agreement and Set Public Hearing:

Supervisor Hartman read the following Resolution:

RESOLUTION ENDORSING PROPOSED JOINT CONSOLIDATION AGREEMENT AND CALLING FOR PUBLIC HEARING REGARDING THE PROPOSED CONSOLIDATION OF WATER DISTRICTS NO. 4 and 5, THE CONSOLIDATED WATER DISTRICT ("CWD")

AND THE MASTER WATER IMPROVEMENT AREA ("MWIA") OF THE TOWN OF EDEN INTO ONE CONSOLIDATED WATER DISTRICT TO BE DESIGNATED AS CONSOLIDATED WATER DISTRICT NO. 2 IN THE TOWN OF EDEN PURSUANT TO ARTICLE 17-A TITLE TWO OF THE GENERAL MUNICIPAL LAW OF THE STATE OF NEW YORK

WHEREAS, there are presently three (3) water districts and one (1) water improvement area of said water districts existing in the Town of Eden, and

WHEREAS, all present indebtedness of said districts and extensions will be paid by an assessment upon the real property parcels located within the existing districts and water improvement areas, and

WHEREAS, there is presently in effect a Lease Management Agreement between the Town of Eden and the Erie County Water Authority ("ECWA") whereby the existing districts are lease-managed by the ECWA, and

WHEREAS, under the Lease Management Agreement, the Town water districts are responsible for the infrastructure and major repairs of the water districts, and

WHEREAS, the Town of Eden and the ECWA have entered into a Memorandum of Understanding whereby the ECWA would provide direct service to all Town water districts, which would include ECWA responsibility for all infrastructure and major repairs, and

WHEREAS, in order to implement the Direct Service Agreement it is necessary to consolidate the water districts and water improvement areas within the Town of Eden and then undertake proceedings under Town Law Section 198 (12) required to sell and transfer all property and facilities of the CWD2 to ECWA, followed by dissolution proceedings for the CWD2, and

WHEREAS, such consolidation with proposed dissolution would provide certain benefits by consolidation, namely:

- a. The costs of future repairs and maintenance of the infrastructure of the districts by a Direct Service Agreement will be borne by the ECWA.
- b. The cost of future extensions of water service will be spread over the entire consolidated district and not just any specific area involved.
- c. All future expenses of maintenance, operation and improvements of the consolidated district would be the responsibility of the ECWA in accordance with a Direct Service Agreement.

THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Eden in its capacity as commissioners of the existing water districts and the MWIA, in regular session duly convened as follows:

RESOLVED, that the Eden Town Board, as commissioners, hereby declares itself Lead Agency for purposes of compliance with SEQRA, and it is further

RESOLVED, that the Proposed Joint Consolidation Agreement for Water Districts Nos. 4 and 5, the CWD and the MWIA is hereby endorsed as required by General Municipal Law Section 752 (1) to commence consolidation proceedings, and it is further

RESOLVED, that a public hearing be and the same hereby is called on July 18, 2019, at 7:00 p.m. at the Eden Town Hall, located at 2795 E. Church Street, Eden, New York to consider the proposed consolidation of Water Districts Nos. 4 and 5, the CWD and the MWIA of the Town of Eden pursuant to Article 17-A Title 2 of the General Municipal Law of the State of New York, and it is further

RESOLVED, that, no later than five (5) business days after commencement of consolidation proceedings by adoption of this Resolution, the Town Clerk shall cause a copy of the proposed Consolidation Agreement along with a descriptive summary thereof, to be displayed and readily accessible to the public for inspection in public places within the Town of Eden; cause the proposed Consolidation Agreement, along with a descriptive summary thereof and reference to the public place or places within the Town where a copy may be examined, to be displayed on the

website maintained by the Town; and arrange to be published a descriptive summary of the proposed Consolidation Agreement along with reference to the place or places within the Town of Eden where a copy thereof may be examined, at least once each week for four successive weeks, in the official newspaper of the Town of Eden.

DULY ADOPTED, this 12th day of June, 2019.
