I am recommending a change in the town's brush/yard waste program. Over the years the cost for this service has increased significantly. The amount of product has also increased, and I believe this is because the contractors know they can dispose of the product here without cost (I believe some contractors even bring brush from out of town projects).

Currently the town provides roadside pick up five times per year for brush. We also offer unlimited access to drop off any yard waste with no limits on size and amount for either. Roadside pick-ups cost \$8,000 and has always been absorbed by the highway fund.

The costs for the town to dispose of this waste is raising significantly. We hire a contractor to grind the product. In 2014 this cost was \$8,000, in 2018 it was \$21,400 and in 2019 it was \$29,795, this expense is taken from the General Refuse Account.

My recommendations include limiting the diameter of what is accepted, either by pick up or drop off. Whole tree disposal will be the residents or contractor's responsibility for disposal. See the attached sheet with all that is accepted/refused with changes in bold. These changes should get our cost under control without eliminating the service completely.

Supervisor Hartman stated that the town is no longer paid for their brush and it has become an expensive part of refuse. Ron Maggs stated that the current policy is being abused by residents, businesses, and people from other towns which is creating an increase cost for tax payers. The highway department checks the waste pile daily for items including stumps, trash, and concrete that is being dumped illegally. The amendments to this policy will keep the current system in check and allow the highway department to continue to pick up brush and yard waste without an increased burden to tax payers. The policy change will be put in the Pennysaver, on the website, on social media pages, and posted at the Highway Department. The Board also discussed looking into a fine for illegal dumping.
