New and Unfinished Business:

1. Addendum Extending Chief Fleschow's Contract:

WHEREAS, the New York State response to the COVID-19 outbreak has severely impacted many municipal functions, including the process of finding a replacement for Chief Felschow who had planned on leaving service to the Town of Eden following the expiration of his current employment agreement which runs through June 26, 2020, and

WHEREAS, Chief Felschow has agreed to extend his period of service for an additional two (2) months to allow the canvassing and interview processes to proceed on a more normal footing once the existing state-imposed limitations on such activities have been eased, and

WHEREAS, the Town of Eden is deeply appreciative of Chief Felschow's willingness to extend his period of service.

NOW, THEREFORE, IT IS HEREBY AGREED AS FOLLOWS:

- 1. The Employment Agreement between the Town of Eden and Chief Felschow made and entered into as of January 1, 2020 is hereby extended and shall run through August 28, 2020, unless terminated soon as provided therein.
- 2. Salary and other compensation shall continue during the two (2) month extension at the same level as pro-rated.
- 3. All other terms and conditions of the said Employment Agreement shall remain in effect as stated therein for the balance of the term, as extended.

11. Ratify Temporary Outside Dining Permit:

Interim Policy for Exterior Dining

WHEREAS, on March 15, 2020, Supervisor Hartman issued an Executive Order declaring a local state of emergency in the Town of Eden and has issued extensions to such state of emergency currently due to expire on June 15, 2020; and

WHEREAS, both travel-related cases and community contact transmission of COVID-19 have been documented in New York State and Erie County and are expected to continue; and

WHEREAS, the Covid-19 Health Emergency has impacted the community's existing restaurants by requiring that they limit their service to take-out only, and that when future business reopening phases are allowed to resume, restaurants with indoor dining will be required to significantly reduce their permitted indoor capacity to maintain social distancing requirements, and

WHEREAS, the Town has established an interim administrative temporary approval policy to permit the Code Enforcement Officer to review requests for temporary outdoor dining provisions to supplement dining capacity being lost on the interior of the restaurant and promote social distancing, consistent with directives and guidance from New York State, and

NOW, THEREFORE BE IT RESOLVED THAT, the Town of Eden Town Board hereby directs the Building Department to implement the Policy for Administrative Approval of Temporary Exterior Dining Areas attached hereto.
