## 11. Letter of Support for an Executive Order on Senior Citizens and Disability Exemptions:

December 8, 2020 The Honorable Andrew M. Cuomo Governor of New York State NYS State Capitol Building Albany, New York 12224

#### Dear Governor Cuomo:

We are writing regarding Section 467 of the New York State Real Property Law, which provides local governments and public school districts with the ability to grant a reduction in the amount of property taxes paid by senior citizens, ages 65 and older, who meet the stated income qualifications and other requirements. The law also affords municipal bodies the capacity to confer a diminution of property taxes paid by individuals with disabilities who qualify by meeting the income requirements and other criteria. The issue is that in order to maintain the exemption on an annual basis, the individual property owner is required to file a yearly renewal application in their local assessor's office, a process which is typically carried out during the current time period.

In light of the COVID-19 pandemic and the many complex challenges that it poses for our general population, and, in particular, our seniors and residents with disabilities who may be immunocompromised, we respectfully request that you issue an Executive Order suspending the requirement to renew the senior citizens and disability exemption for one year by local option.

Doing so will ensure that these residents, who are more susceptible to the coronavirus than others, continue receiving the financial assistance they are entitled to under the law, while making certain that they will not have to jeopardize their health and well-being by traveling to their local municipal building and likely encountering or interacting with other members of the public at that time.

We all understand how critical it is that we take the necessary steps to protect our residents during this public health crisis, and we believe that the issuance of an Executive Order as described herein above is a straightforward, common sense measure that would help keep New Yorkers safe in the face of COVID-19.

Thank you in advance for your attention to this matter and for your consideration of our request.
