## 5. Local Law 1-2021 – Flood Damage Prevention:

A local law for Flood Damage Prevention as authorized by the New York State Constitution, Article IX, Section 2, and Environmental Conservation Law, Article 36

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF EDEN, COUNTY OF ERIE, STATE OF NEW YORK AS FOLLOWS:

Chapter 114 of the Code of the Town of Eden entitled "Flood Damage Prevention", adopted by Local Law No. 2-2019 is hereby repealed in its entirety and replaced with the following (including the "Appendix of Forms") as a new Chapter 114 of the Code of the Town of Eden also to be entitled "Flood Damage Prevention" which shall take effect immediately upon adoption and filing in the Office of the Secretary of State of the State of New York.
