Resolution by the Town Board approving and endorsing the Town of Eden in its application to NYS Homes and Community Renewal for funding under the New York Main Street Program.

11. Hamburg Dispatching Contract:

Hamburg currently does overnight dispatching and will be taking over full-time dispatching. This agreement is in the amount of \$51,168.30 from 2021-2024, \$51,679.98 for year 2026, \$52,196.78 for 2027, \$52,718.75 for year 2028, and \$53,245.95 for year 2029.
