## **Hearing of Visitors:**

Susan Engle, 8196 N. Main St.: Addressed noise issues with live music at Rayzor's Dog House. As neighbors of the property the music is playing at loud decibels and they are able to hear it from inside their home and on their porch. She asked the Town Board for assistance to rectify the issue.

Joe Pietrkiewicz, 76 Sharon Pkwy, Buffalo: Addressed concerns with disrespectful treatment to the owner of Rayzor's Dog House by the Eden Police Chief on June 19, 2021 while his band was playing at the business. He stated he rectified the noise violation by reducing the sound and changing the direction of his speakers.

Pursuant to a resolution of the Town Board of the Town of Eden, County of Erie and State of New York, adopted on June 9, 2021, **NOTICE IS HEREBY GIVEN** of a **PUBLIC HEARING** to be held by the Eden Town Board at the Eden Town Hall, 2795 East Church Street, Eden, New York at **7:45 PM on the 14<sup>th</sup> Day of July, 2021**. The purpose of the said Public Hearing is to consider the issuance of a **Special Use Permit to the applicant, Eden Solar LLC**, allowing a Utility Scale Solar Energy System at 7501 Sisson Highway. All interested parties may attend and be heard.

Supervisor Hartman opened the Public Hearing by giving background on the solar project.

- Project has been in works for 2.5 years
- Review by Planning Board multiple times
- Positive SEQR Declaration
- Site Plan Review has taken considerations to mitigate concerns of noise, screening, entrance, farmland protection, benefit to Town, etc.
- After a previous public comment period all comments were taken into consideration and problems were mitigated
- Project is through a private contractor and the land owner and is not a town project

The following topics were addressed:

Drainage: current issues with water on surrounding properties, residents concerned with additional run-off, many yards have pools over water in them when it rains

Mike Cucchiara, Nexamp; Worked with Planning Board on drainage concerns and submitted a fully approved SWPP (Storm Water Protection Plan), a grass field will be below the panels to absorb run-off.

Screening: residents do not want to view solar panels from their homes and feel that this project does not belong in this space.

Mr. Cucchiara: Vegetative screening will be planted along the open perimeter of the solar field (50'-80' setback from property line) and will include 4'-6' tall deciduous and evergreen trees, the solar field (200' set back from property line) will not be invisible but will be screened.

Notification: residents raised concerns about failure of being notified of the solar field project.

Supervisor Hartman: Project has been under review for 2.5 years and has been through many Planning Board and Town Board Meetings, as well as Public Hearings. All residents within 500' were sent certified letters for the Public Hearing.

Decommissioning Plan: residents expressed concern over decommissioning costs, disposal of units, and effects on farmland

Mr. Cucchiara; Decommissioning plan follows guidelines; everything is removed from the land at the life of the project (40 years) and it is returned to its original condition for farming. Any reusable materials will be salvaged or recycled; debris will go into a landfill. Decommissioning funds are bonded.

Bill Trask, Town Attorney, spoke extensively regarding the solar project:

- NYS has an aggressive Green Energy Program, 20+ megawatt projects are state run and have zero town control
- This project is at 3.5 megawatts and Town is able to have say and control over process
- 2.5 years in review by Town Board, Attorney, and Planning Board
- Project must meet strict conditions for the Special Use Permit
- Special Use Permit is reviewed and renewed annually to ensure solar company is in compliance
- Decommissioning Agreement has been strenuously negotiated between all parties and includes a bond for the cost of restoration to the property.
- Host Community Agreement is a fund that will assist the Town in preserving farmland in the future
- Location of project is not up to the Town as this is a project from a private company

Additional concerns were discussed and addressed.
