All reports are on file in the Town Clerk's office.

Public Comments on Agenda Items Only:

Elmer Ploetz submitted a petition to the Town Board against removing the position of elected assessor and changing to an appointed assessor.

The following topics were brought up:

- Additional ways to get information to residents (Pennysaver), residents do not feel like they know where to find information
- Elected assessor vs. appointed assessor should be brought to a public vote
- Elected position should not be taken away from the voters

Supervisor Hartman stated that this meeting is to set the Public Hearing to have a public comment period on the proposed changes. Eden is the only town in Erie County that has an elected assessor position. An appointed assessor would be a six-year appointment. Assessors need to follow the law and meet criteria to be eligible to assess property, this would ensure the proper training is being followed and adhered to. Two of three elected assessors are on board with the changes.

New and Unfinished Business:

1. Approval of Tentative 2022 Town Budget as Preliminary Budget:

Supervisor Hartman stated that as a result of increased revenues from sales and mortgage tax there is a slight decrease in town tax for 2022. (Less than 1 penny per \$1,000 of assessed value)

Notice to the Citizens of the Town of Eden:

A Public Hearing will be held on October 13, 2021 at 7:30 pm at the Town Hall regarding the use of Federal Community Development funds on the Town of Eden.

Resolution to Erie County for Road Study East Church Street and Jennings Road

WHEREAS the Town of Eden has seen an increased amount of accidents at the intersections of East Church Street and Jennings Road, and

WHEREAS there has been five (5) accidents in the last 14 months with injury and property damage at said intersections, and

WHEREAS the Town of Eden Town Board and Police department feel that this intersection needs to be evaluated to see the cause of the increased accidents, and

WHEREAS there is only a 2-way stop blinking red/yellow light at said intersection, and

WHEREAS both East Church Street and Jennings Road are Erie County Roads

NOW, THEREFORE, BE IT RESOLVED: The Town of Eden is requesting Erie County to conduct an All-way Stop Study for the intersection of East Church Street and Jennings Road in the Town of Eden BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to Commissioner William Geary, Erie County Traffic Safety Engineer, Gina Wilkolaski, Legislature John Mills and Erie County Executive Mark Poloncarz.

The Town Board of the Town of Eden, duly convened in a regular session does hereby resolve pursuant to the provisions of Section 6-C of the General Municipal Law of the State of New York that the Town Supervisor of the Town of Eden be and is hereby authorized and directed to appropriate a sum not to exceed \$40,000.00 from the Restricted Recreation Equipment Reserve Account A.878.4 of the Town of Eden for the a New/Unused 2022 Ford Super Duty F-250 XL 4WD Truck plus plow.

13. Special Use Permit - Cazenovia Recovery Systems:

Councilperson Byrnes asked Chief Savage is the property in question is a "problem property." He responded that the police department has had a few calls at the residence, mostly of people who want to leave and want a ride to another Town. Chief has spoken to management over the issues.

Susan Bissonnette, the Director of the house, gave Chief Savage her information for future issues.

MOTION was made by Supervisor Hartman to approve the Special Use Permit for Cazenovia Recovery Systems at 9136 Sandrock Road, for the Turning Point House Alcohol Rehabilitation Center through December 31, 2022 subject to the following conditions;

- 1. Payment in lieu of taxes equal to the full value assessment will be paid to the Town of Eden
- 2. Maximum capacity not to exceed 30 residents
- 3. All persons admitted must have alcoholic abuse as the primary cause for entering the facility
- 4. Town of Eden residents will be given preference for admission to this facility
- 5. Any self-help meeting scheduled at the community residence shall be restricted to residents and their personal guests, maximum 20 people. No such self help meetings will be listed in any meeting schedules or open to the respective recovering public.
- 6. The Special Use Permit may be renewed on a yearly basis, starting 2023, by the Eden Town Board if all requirements have been adhered according to the most recent Special Use Permit.
