Supervisor Hartman proposed a budget transfer of \$11,500 using ARPA funding for the new boiler for the Highway Department. Ron Maggs stated that Highway has \$3,000 of assigned funds from 2021 and room in the 2022 budget to use a portion of that funding but the Town Board would need to come up with an additional \$5,000 in funding for the boiler replacement. There was additional discussion about what account the funds should come out of as some Town Board members feel that the majority of ARPA funding should be preserved for Swartz Field updates. It was agreed upon that \$5,000 would be transferred from ARPA funding for the Highway Department boiler.

Ron Maggs commented to the Town Board that the Highway Department is still waiting on ARPA funding for repair of town roads.

Per New York State Agriculture and Markets Law Section 303-b, the Erie County Legislature designated September 1 through September 30 as the annual thirty-day period during which landowners may submit requests to include predominantly viable agricultural land into an existing certified agricultural district.

Copies of the application form have been provided to Municipal Clerks, Assessors, and Chief Elected Officials for distribution to interested landowners. The application is also available on the DEP website at www.erie.gov/agenrollment.

The Erie County Department of Environment and Planning will accept applications from September 1 through September 30. Any questions on this process should be directed to the Erie County Department of Environment and Planning.

A public hearing will also be scheduled at a later date to consider all inclusion requests and the recommendations of the Erie County Agricultural and Farmland Protection Board.

12. Proposed Local Law 8-2022 - Tax Bill Inserts:

Town of Eden

Proposed Local Law No. 8-2022

A local law allowing for the insertion of informational enclosures of public concern with Town Tax bills. Be it enacted by the Town Board of the Town of Eden, Erie County, New York, as follows:

Section 1. <u>LEGISLATIVE INTENT</u>

Section 1826 of the Tax Law of New York State forbids a municipality from mailing or delivering with tax bills any notices, circulars, pamphlets, cards, or similar printed materials unless the municipality has passed local legislation pursuant to Municipal Home Rule Law Sections 10 and 22 allowing for that practice and so long as neither the legislation nor the practice provide for the dissemination of political or propaganda materials. The purpose of this local law is to authorize the Town Board, by unanimous resolution, to allow the Town Clerk to enclose with the tax bills certain notices or other enclosures allowed by law concerning matters of public interest, but excluding enclosures of a political nature, entailing propaganda, or advertisements.

Section 2. <u>ADOPTION OF LOCAL LAW SUPERSEDING SECTION 1826 OF THE TAX LAW AUTHORIZING INFORMATIONAL ENCLOSURES WITH TAX BILLS</u>

Pursuant to authority granted by Municipal Home Rule Law Sections 10 and 22, this local law is adopted authorizing the Eden Town Board, by resolution unanimously adopted, to instruct the Town Clerk to enclose notices, circulars, pamphlets, cards, handbills or other enclosures allowed by law concerning matters of public concern, subject to the following:

- A. Such enclosures shall exclude any and all matter of political nature, entailing propaganda or any type of advertisement.
- B. Each enclosure shall be approved by a separate unanimous resolution of the Town Board.
- C. Said enclosures shall be included in the County/Town tax bills only.

Section 3. EFFECTIVE DATE

This Local Law shall take effect immediately upon filing with the New York Secretary of State.

Ron Maggs recommended MJ Mechanical for the boiler replacement in the amount of \$14,400

19. Farm Laborers Wage Board Resolution:

Councilperson Byrnes stated that the Buffalo News printed an article outlining the reduced overtime threshold for farmers from 60 hours to 40 hours per week and discussed how it would affect local farmers in the town of Eden. After further discussion he offered the following resolution:

WHEREAS The Town of Eden is in full support of Senator Borrello to repeal the act Section 674-a of the law, relating to establishing the Farm Laborers Wage Board and urging Governor Hochul to eliminate the three-member Farm Laborers Wage Board, and

WHEREAS the Wage Board is charged with making a recommendation on whether to reduce the current 60-hour overtime threshold for farm workers to 40 hours, and

WHEREAS in January 2022, after numerous public hearings on the issue that included testimony from farmers, farm workers and industry stakeholders, the Wage Board recommended lowering the threshold, despite the fact that 70 percent of the testimony conveyed the harm that would be caused by such a change, and

WHEREAS the Wage Board proposes four-hour decreases in the overtime threshold every other year. Farmers would pay overtime wages up front and then be reimbursed for overtime hours after the fact which it would be unlikely, hours worked over 60 hours would be covered by tax credit, and

WHEREAS the Wage Board has just one member with an agriculture background, making it ill-equipped to render sound, informed decisions concerning New York State's critically important agriculture agriculture industry, and

WHEREAS data from a 2021 Cornell University study is being ignored by the Wage Board which results in findings that show lowering the threshold would economically hurt both farmers and farm workers, and.

WHEREAS New York State farmers continue to face a tremendous number of challenges outside of their control including changes in consumer demand leading to price change, obtaining labor, climate change regulations and mandates, land management policies, foreign and regional competition, NYS regulations, livestock and crop disease, and

WHEREAS farmers are heavily relied on to continue to produce food during shortages throughout the Country while keeping in mind, farmers and farm workers remained constant during the pandemic, and

WHEREAS New York State farms donate the majority of produce used in food pantries and local feeding programs. These programs will suffer due to higher mandated costs of labor, making less donated produce available to Nourish NY programs, and

WHEREAS Town of Eden is urging state legislators to provide the farmers and farm workers relief from the already onerous burden the Farm Workers Fair Labor Practices Act and other existing government mandates which have placed our farms at a competitive disadvantage with neighboring states and Canada. Now, therefore, be it

RESOLVED Town of Eden emphatically opposes any decrease to the 60-hour farm worker overtime threshold proposed by the Farm Laborers Wage Board. Be it further

RESOLVED Town of Eden urges Governor Hochul to strongly consider Senator Borrello's request of repealing the act, section 674-a of the labor law, relating to establishing the Farm Laborers Wage Board and eliminating the three-member Farm Laborers Wage Board. Furthermore, be it

RESOLVED Town of Eden directs the Clerk of Eden to submit a copy of the adopted resolution to Governor Hochul, Senate Majority Leader Stewart-Cousins, NYS Assembly Speaker Heastie, Assemblyman Hawley, Senator Borrello, Senator Rath, NYS Labor Commissioner, NYS Agriculture and Markets Commissioner, NYS Farm Bureau, Erie County Farm Bureau, NYSAC and Inter-County Association of Western New York. Be it further

#197-2022: MOTION was made by Councilperson Byrnes to approve the resolution as presented; seconded by Councilperson Wilhelm; Ayes: Byrnes, Wilhelm, Sam, Ventry; Opposed: Hartman; Abstain: None; Motion carried.

Supervisor Hartman stated that she received the resolution that morning and did not have enough time to thoroughly research it, she offered a brief statement on her initial findings and said she would be voting no for that reason.
