Mr. Reed called the meeting to order at 7:00pm and announced that both alternate members will be acting at full capacity for tonight's meeting. **Mr. Reed made a motion to approve the minutes from the November 6, 2024 meeting; seconded by Mr. Eppolito. Motion approved unanimously.**

### Eden Knoll Solar LLC – SEQR Review

**Mr. Reed made a motion to call an executive session to review confidential attorney client communication related to the Eden Knoll Solar project; seconded by Mr. Buchanan. Motion approved unanimously.**

**Mr. Reed made a motion to end the executive session; seconded by Mr. Tarasek. Motion approved unanimously.**

The Planning Board reviewed SEQR Part II. Several sections were determined to be areas where a moderate to large impact may occur:

- **Impact on groundwater** – There is no public water in this area. Residents rely on wells.
- **Impact on Plants and Animals** – The proposed action may substantially interfere with nesting/breeding, foraging, or over-wintering habitat for the predominant species that occupy or use the project site.
- **Impact on Agricultural Resources**
  - The proposed action may impact soil classified within soil group 1 through 4 of the NYS Land Classification System.
  - The proposed action may sever, cross or otherwise limit access to agricultural land (includes cropland, hayfields, pasture, vineyard, orchard etc.).
  - The proposed action may irreversibly convert agricultural land to non-agricultural uses, either more than 2.5 acres if located in an Agricultural District, or more than 10 acres if not within an Agricultural District.

- The proposed action may result, directly or indirectly, in increased development potential or pressure on farmland.
- The proposed project is not consistent with the adopted municipal Farmland Protection Plan.
- **Impact on Aesthetic Resources**
  - The proposed action may be visible from publicly accessible vantage points year-round.
  - The situation or activity in which viewers are engaged while viewing the proposed action is: Routine travel by residents, including travel to and from work.
- **Impact on Open Space and Recreation**
  - The proposed action may result in loss of an area now used informally by the community as an open space resource.
- **Consistency with Community Plans**
  - The proposed action's land use components may be different from, or in sharp contrast to, current surrounding land use pattern(s).
  - The proposed action is inconsistent with local land use plans or zoning regulations.
  - The proposed action is inconsistent with any County plans, or other regional land use plans.
- **Consistency with Community Character**
  - The proposed action is inconsistent with the predominant architectural scale and character.
  - Proposed action is inconsistent with the character of the existing natural landscape.

**Based on the above, Mr. Reed made a motion for the below resolution recommending a positive declaration of environmental significance for the proposed Knoll Eden Solar Project located at 9549 Knoll Road under SEQRA; seconded by Ms. Schmitt-Rouf. All in favor; motion approved unanimously.**

**TOWN OF EDEN PLANNING BOARD RESOLUTION  
RECOMMENDING A POSITIVE DECLARATION OF ENVIRONMENTAL SIGNIFICANCE  
FOR THE PROPOSED KNOLL EDEN SOLAR PROJECT LOCATED AT 9549 KNOLL ROAD  
UNDER SEQRA**

**WHEREAS**, in May 2024, the Town of Eden Town Board (“Town Board”) received an application for the development of a 4.0 MW solar facility from Sustainable Energy developments, DBA GreenSpark Solar/Knoll Eden Solar, LLC (“Applicant”), and

**WHEREAS**, as part of its application, the Applicant submitted a Full Environmental Assessment Form dated May 30, 2024 and an updated form dated October 22, 2024, and

**WHEREAS**, on June 12, 2024 the Town Board classified the project as a Type I Action under the New York State Environmental Quality Review Act (“SEQRA”) and assumed lead agency pursuant to 6 NYCRR 617.6(b)(1), and

**WHEREAS**, on June 12, 2024 the Town Board referred the Project to the Town of Eden Planning Board (“Planning Board”), and

**WHEREAS**, the Planning Board has reviewed the application and conducted public hearings on the proposed project on August 7, 2024, September 4, 2024, and December 4, 2024, and

**WHEREAS**, the lead agency must issue a positive declaration if it determined that the proposed action may have a significant adverse impact on the environment, and

**WHEREAS**, upon review of the FEAF and the relevant environmental criteria under SEQRA, the Planning Board believes that the preparation of a Draft Environmental Impact Statement (“DEIS”) is warranted.

**NOW THEREFORE**, the Planning Board hereby finds that the Knoll Eden Solar Project may have potentially significant adverse impacts on the environment.

**AND THEREFORE**, the Planning Board finds that the proposed project may have potentially significant adverse impacts to the conversion of agricultural land and is in material conflict with the Town and County’s Farmland Protection Plans, and

**AND THEREFORE**, the Planning Board finds that the proposed project may have potentially significant adverse impacts to aesthetic resources as it will be visible from public rights of way and to adjoining and nearby private properties, and

**AND THEREFORE**, the Planning Board finds that the proposed project may have potentially significant adverse impacts to groundwater, if improperly installed or damaged panels, introduce containments to existing ground wells, and

**AND THEREFORE**, the Planning Board finds that the proposed project may have potentially significant adverse impacts to community character by converting open land to use as a utility, and

**AND THEREFORE**, the Planning Board hereby recommends that the Town Board adopt the attached EAF Part 2 and make a positive declaration of environmental significance with respect to the Knoll Eden Solar Project, finding there is a potential for at least one or more potentially significant adverse environmental impacts that may result from the Proposed Action.

### **Other Business – Existing Code Reviews**

#### **Lighting Requirements**

After discussion of the proposed residential lighting code, it was determined that it is too specific and would be very time consuming to enforce. Residential lighting has not been an issue for code enforcement. Mr. Eppolito and Mr. Timblin will work with Dr. Meyer and the Code Review Committee to work out the proposed code.

**Mr. Reed motioned to adjourn the Planning Board meeting, seconded by Ms. Crowe; Motion approved unanimously.**
